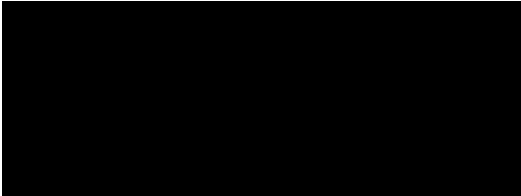

OFFICE BEARER'S REPORT FOR THE PERIOD ENDED 31 DECEMBER 2024

The Office Bearers present their report and accounts for the period ended 31st December 2024.

The accounts have been prepared in accordance with the accounting policies set out in note 1 to the accounts and comply with the charity's constitution, applicable law and the requirements of the Statement of Recommended Practice, "Accounting and Reporting by Charities" issued in March 2005.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Constitution

Lasswade Athletics Club (the Club) is a Scottish Charitable Incorporated Organisation (SCIO). It was registered in its current legal form on 6th March 2019. The Club was previously an unincorporated association but changed its legal status to a SCIO. The assets of the unincorporated association were transferred to the SCIO on 27th March 2019 following agreement at the annual general meeting of the Club.

Appointment of Trustees

Members can elect trustees at the Club's Annual General Meeting. All trustees must not be disqualified from being a charity trustee and not an employee of the club. Trustees are elected for a period of 1 year but are eligible for re-election. There must be a minimum of 3 and a maximum of 8 trustees.

Management

The activities, strategic development and finances of the Club are overseen by a Board of trustees and Committee members who meet periodically to consider the Club development plan, financial position, and any other material issues.

OBJECTIVES AND ACTIVITIES

Charitable Purposes

The Club is a non-profit distributing charity whose principal objectives are:

- (a) The advancement of public participation in Athletics as a sport.
- (b) To provide recreational facilities and/or organise recreational activities, available to members of the public at large, with the object of improving the conditions of life;

In furtherance of the above, the club shall:

- (i) Promote and encourage individuals towards accreditation for coaching and the role of competition officials.
- (ii) Offer all members of the community the opportunity to take part in keep-fit and athletic activities, wither for leisure or at a competitive level and where it is complementary to school and youth organisation activities and encourage family participation.
- (iii) Motivate people towards greater individual excellence and encourage a spirit of fair competition, thus the better to equip themselves to develop their personal resource of mind, body and spirit as a mature, creative and responsible member of their communities.

ACTIVITIES

Lasswade Athletics Club, based at Dalkeith Community Campus, provides coaching and competitive opportunities in athletics for members of the community aged 8 and above. Training takes place twice a week and covers all disciplines, supporting over 100 children and adults with a structured programme of individual and team competitions throughout the year—from local meets to national championships.

The club also delivers opportunities for competition by organising annual cross country events and a 10-mile road race, which welcome both members and guest participants. These events not only enhance competitive experience but also raise valuable funds for the club.

Lasswade's volunteers are key to the club's outreach. In partnership with Active Midlothian, they help deliver local school events, including the Primary Schools Cross Country Championships and the Primary and High School Athletics Championships in summer.

The volunteer coaching team is supported by a Club Development Officer, employed by Scottish Athletics with partial funding from Lasswade AC.

ACHIEVEMENTS AND PERFORMANCE

2024 saw continued momentum from 2023, with increased athlete participation on the track and in cross country, across distances ranging from 60 metres to marathon.

- **National Cross Country Championships:** Lasswade athletes earned individual medals, and the Under 15 Girls team secured a brilliant **gold medal**.
- **Annual 10-Mile Road Race:** Returning for the first time since the pandemic, the event was warmly received, despite lower participation. Lasswade athletes shone with **first place in the women's race and third place in the men's**.
- **Track Competitions:** Athletes competed in the Forth Valley League, Central and South Scotland League, Under 12s SuperTeams, and the Scottish Athletics Indoor League—achieving strong participation and results throughout.
 - o Under 12s SuperTeams reached the **National Final**, finishing **13th of 35 teams**.
 - o At the **National Age Group Championships**, Lasswade athletes earned **four medals (2 gold, 2 silver)**.

In league performance:

- 3rd place in Division 2 of the Forth Valley League
- 4th place in Division 2 of the Central and South Scotland Athletics League

The **Club Championships** in September attracted over **80 young athletes (ages 8–16)**—a slight increase from 2023.

October brought national recognition when Lasswade's **young female team won gold** in the National Cross Country Relays. In a highly competitive Scottish endurance scene, this was a standout achievement and a reflection of the dedication shown by the club's endurance coaching team.

INDEPENDENT EXAMINER'S REPORT TO THE MEMBERS ON THE UNAUDITED ACCOUNTS OF LASSWADE ATHLETICS CLUB


