Structure

The Charity is a SCIO (Scottish Charitable Incorporated Organisation) governed by a formal Constitution and supports an *Implementing Partner*, *AYDAP Liberia*, which is a separate legal entity registered as a NGO in Liberia with only Liberian members and is not affiliated to or associated with AYDAP in Scotland

The Charity is not affiliated to any other body

Charitable Purposes

To advance the education of young people in Africa and Worldwide through the provision of information, guidance and services in relation to health, the environment and culture

To alleviate poverty among young people in Africa and Worldwide by enabling them to access education and career choices through the provision of employment guidance, advice and information.

Activities

In the year under review the Charity received funds of £13,255 from Donations and Trusts and remitted £15,514 to *AYDAP Liberia*.

Implementing Partner

For some years *AYDAP Liberia* worked among young people in that country in a number of secondary schools with a programme of drama, dance, music and group discussion support using local Liberian volunteers and their own Liberian team with a theme of Sexual Exploitation and Abuse (S.E.A) to encourage the students to learn important life skills and an increased awareness of the social and health issues resulting from such abuse.

AYDAP Liberia has made advanced progress in the establishment of a new school at Sand Beach Junction in River Cess County in Liberia which has been described by Children In Crisis as one of the most remote, marginalised and excluded areas in that country.

AYDAP Liberia has been well recognised effectively as partners by both UNICEF and UNDP in Liberia.

Financial Policy

All available funds raised in the UK are remitted to AYDAP Liberia in tranches agreed in an annual Budget to support the activities described above.

This Charity does not have any Restricted Funds.

The statement of accounts is prepared on *the Receipts and Payments* basis in accordance with the requirements of the Office of the Scottish Charity Regulator (OSCR) and shows a closing Balance on hand of £2,055 which will be remitted to AYDAP Liberia in April or May 2024.

Donated Services

The Executive Committee contribute fundraising, administration, and accounting expertise in running the Charity in Glasgow, Scotland on a wholly unpaid voluntary basis. The Committee are in continual contact with the team at AYDAP Liberia..

Donations

The Charity has been supported throughout the year by private donations totalling £526, which qualified for Giftaid Tax which will be recovered shortly. All these donations have been acknowledged with thanks.

Grants

The Committee are pleased to report that income from Charitable Trusts in Scotland has been maintained and the Trustees are delighted at this excellent and welcome support.

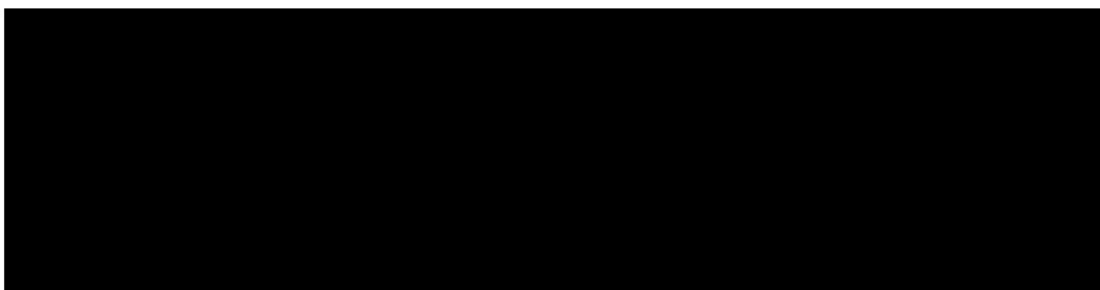
Executive Committee

AYDAP is a member of SIDA (Scotland's International Development Alliance)

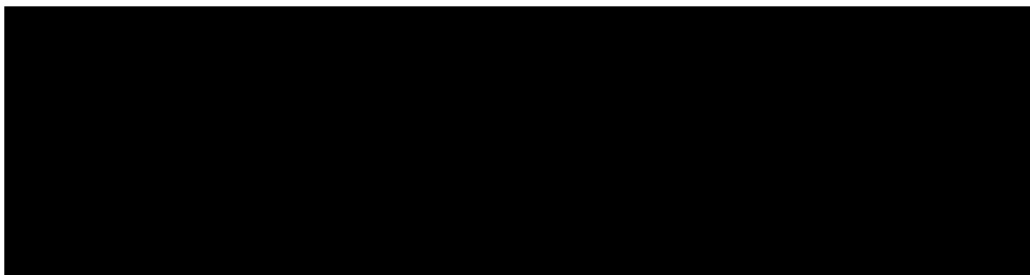

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) 2005 Act and the Charities Accounts (Scotland) Regulations 2006. The charity trustees consider that the audit requirement of Regulation 10(1) (d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

Basis of Examiner's Statement

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit and, consequently, I do not express an audit opinion on the accounts.
