Objectives: Promoting the instruction of girls of all classes in the principles of discipline, loyalty and good citizenship.

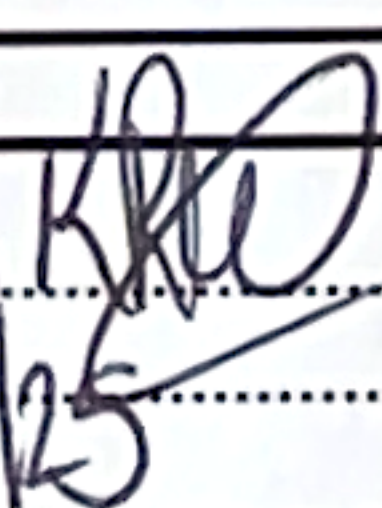
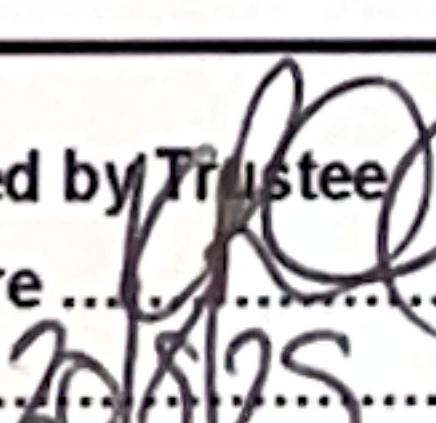
