helping people on the streets and at various venues, day and night.

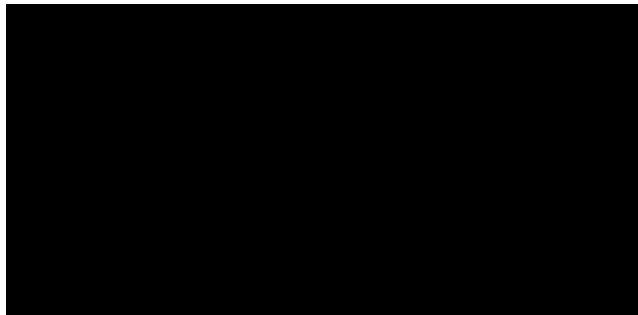
