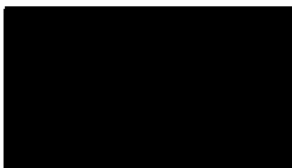
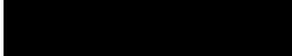
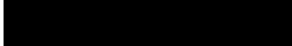
1. The prevention or relief of poverty
