While the fundraising target for the year was also set at £5,000, the charity raised a surplus of £582, falling short of the target. Despite this, the overall financial position remains strong due to the healthy reserves.

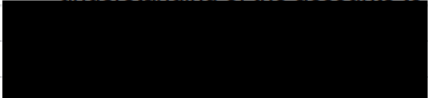
