Chairman's Report

There has been a very good sprinkling of private parties and events through the 12 months.

Last December the Hall Committee held a very successful quiz night and have now installed a WiFi hub in the hall.

Sincere thanks are due to the hall organising committee (8 members) for all the efforts they have put in over the year. Our two new members -Harry Maxwell and Blair Mason have made excellent contributions.

Our treasurer Terry Howat is stepping down from her role after many years of diligent service. Through that time Terry has kept a sharp eye on all things financial and also the organisation of the annual maintenance tasks. Terry has also overseen a number of changes which have recently become necessary in our banking patterns. To ease the load of treasurer it could be possible to spread the burden of tasks which Terry has previously overseen.

And it is now the right time for myself to step down as chairman.

In fact the three office bearers' posts need to be filled, as the committee has been functioning without a secretary for some time.

It is right that the office bearers posts should be refreshed, and there is no crisis here, but the successful continuation of the hall requires that these posts be filled straight away.

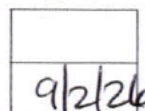
