


Objectives and activities

Charitable purposes

To advance the Christian religion for the public benefit in accordance with the Statement of Faith in the Schedule hereto attached in such parts of the United Kingdom and the world.

Summary of the main activities in relation to these objects

Cumbernauld Vineyard Church continues to operate from their base in the Town Centre of Cumbernauld. The CVC Hub provides a space for the community as well as our regular church activities and continues to work with other local organisations to identify and meet the needs of the local community where possible.

Activity Summary

Weekly Connect Group & Warm Space

Wednesday nights continue to be our weekly Connect Group where we meet in a local pub. This continued to be a popular weekly setting where we were able to encourage and support one another. In November 2023 we launch a Warm Space in the form of our Coffee, Cake and Chat on a Monday. Volunteers provided a space for the community to meet & enjoy a cuppa and a treat whilst encouraging the building of relationships and support networks.

Community Engagement & Social Events

During August of 2024, we continued with Music Workshops - weekly events open to families in the local community - which aimed to bring people together to teach some basic rhythm and guitar skills. These events were well attended and attendees were invited to perform at the monthly Family Open Mic Night at the end of August. We held a number of social events throughout the year, focussed on families, ladies and men's events. These were an opportunity to invite the community along to a range of events where it was a chance to connect & build relationships. CVC also supported a number of charity events locally including a MacMillan Cancer Support Coffee evening and the local gala day where we volunteered alongside the community. We also hosted an Afternoon Tea Event which brought together members of the community who are supported by a number of local organisations, and this was made possible through donations from a local workplace. As a church we became a collection point for the local selection box appeal, something which we have now supported for several years - run by a member of the local community. In May 2024 we launched a Games Night in the CVC Hub as an opportunity for families from the community to come and enjoy a night of fun together.

Repair Cafe

Repair Cafe continued to run monthly in the Hub through 2023 and 2024, creating a space for items to be repaired in partnership with the owner of the item. This space continued to demonstrate our commitment to the environment and in particular, to reducing landfill by upskilling and recycling.

Lego Club & Children's Events

This year we had a focus on building momentum with our children's and families events. Alongside our monthly Lego Club which continues to see families from the community enjoy the creative space that Lego Club creates, we expanded this to a Sunday each month where Lego Club preceded our Kids service. This was an opportunity for families to enjoy the Lego Club space and explore faith in a relaxed environment.

Family Open Mic Nights

Our popular Family Open Mic Nights took place during the last Friday of each month and saw adults and children alike enjoy performing. This space was created as a space where people would be able to come and sing/play instruments in a supported and encouraging environment and has grown to welcome people performing from as young as 3 right through to those who are in their more advanced years. At Christmas, we held a fundraiser event for a local charity which was successfully supported by a number of local businesses.

Achievements and performance

Summary of the main achievements of the charity during the financial period

Regular Church Activities

Our monthly rhythms of church continued during 2023 and 2024 with the first and third Sunday of each month, the Lego Club on the second Saturday and a Family Service on the last Sunday of each month. Everyone is welcome to attend and explore faith, regardless of their faith background. In December 2023, we launched a weekly prayer initiative called 'On Your Knees' where the church congregation were encouraged to pray for our local community in Cumbernauld. We also held a number of 'Get to know us' events across the year which was an opportunity for people to meet the church leaders & get to know more about what Cumbernauld Vineyard does and the heart behind the church.

Children & Families Worker

In May 2023, we employed a Children & Families worker to support the work of Cumbernauld Vineyard Church.
