The G15 Youth Project SCIO is a voluntary organisation based in Drumchapel, Glasgow, dedicated to empowering young people. Established in 1997, the organisation operates as a registered charity under the Office of the Scottish Charity Regulator (Charity Number SC050397). As a service designed by young people for young people, G15 Youth Project remains committed to fostering an environment where individuals aged 12 to 25 can engage, connect, receive support, and feel safe.

A proud recipient of the Queen's Award, the organisation celebrates 28 years of serving the young people of the Drumchapel community, offering a diverse range of services that promote inclusion, one-to-one support, and opportunities for positive life choices through an extensive programme of activities.

This report covers the period from 1st April 2024 to 31st March 2025-a time when society struggled with the ongoing rise in food and fuel poverty significantly impacted the daily lives of young people and their families in our community.

Throughout the year, the G15 team remained steadfast in their mission, collaborating with partner agencies and working tirelessly to support local young people. On average, the team engaged with up to 180 individual young people per week, delivering impactful programmes and strengthening the fabric of our community.

The trustees present their report with the financial statements of the charity for the year ended 31 March 2025. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and aims

When setting our outcomes we stated:-

1. Young people will access our resources in order to seek employment and training opportunities
2. We will provide transition to adulthood programs
3. Young people will participate in formal and non-formal activities offering opportunities to connect with positive people and places and challenges/supports that promote growth and personal development
4. We will enhance young people's prospects of gaining employment or further education.
5. We will provide structured group work for young people to develop skills, positive attitude and resilience for employment, encourage commitment to their future.
6. We will support young people to become engrossed or passionate about something that matters e.g learning and understanding the importance of learning and how it connects to their future.
7. We will improve young people's aspirations, confidence, decision making capacity and involvement in community life. Support them to have the opportunity to voice their ideas and have input into programs, policies and practices that affect them.
8. We will tackle and breakdown territorialism, reduce the impact and incidence of anti-social behaviour perpetrated by young people in the community.
9. We will tackle social exclusion using our detached youth work team by targeting young people who are not currently accessing any support.
10. G15 youth project will support our youth members to improve their general health & wellbeing through increased participation in our summer/winter programmes. We will address the issue of youth employment, anti-social behaviour and the positives of making the right choices and participating, and encourage and support at every level of engagement and work with young people to develop their dreams and aspirations. There will be greater confidence and self-esteem of young people.

Significant activities

G15 Youth Project is now in its 28th year of service to the young people of Drumchapel. Through the continued support of our members, the community, funders and benefactors and of course our dedicated staff and management committee, the Project continues to strive in its mission to provide a variety of services to young people.

Volunteers

Volunteering

Our members are always given the opportunity to get involved in the organisation. For 16- 25 year olds this can be to serve on the Management Committee, become a volunteer youth leader shadowing the staff. 12-15 year olds can 'be on duty'; this could be covering the register, timing games, taking names for competitions, setting up and dismantling. All members get the opportunity to take the lead on small pieces of work. This will always be available to young people. Volunteering opportunities are provided to encourage young people to develop themselves as role models, leaders and mentors.

Volunteering is sociable and a great way for members to meet new people. They meet like-minded people and share ideas and thoughts with others. They give something back to the local community and help change people's lives. Volunteering helps young people gain skills that they can use in all aspects of your life and it's also a good way to use their existing skills to help others. Volunteering also gives young people experience that they can build onto their CV.

ACHIEVEMENT AND PERFORMANCE

Charitable activities

SHAPE Programme

This programme is Funded by the National Lottery Improving Lives Fund. The SHAPE programme has provided exceptional support to young people, empowering them through a youth-led approach.

This 12-week rolling programme offers a diverse range of activities, including Walk n Talk, mindfulness, photography and editing, arts and dance, and one-to-one support. SHAPE has made a significant impact, receiving recognition within the community and beyond for its success in supporting young people.

Through outcome-based support planning, we have delivered tailored one-to-one services, helping young people work towards their personal goals. Our programme has been instrumental in re-engaging students with education, rebuilding relationships at home and school, and fostering positive mental health and well-being. As a result, participants have experienced brighter days, improved emotional health, and a reduction in self-harming and suicidal thoughts.

Over the past year, our group sessions have focused on anxiety, low mood, lack of sleep, overcoming negative thinking, school and how important it is, family relationships. Many of the young people have struggled with heightened anxiety about attending school, college, or social situations. SHAPE has provided essential support, offering a structured yet flexible space to help them navigate these challenges.

The programme is making a tangible difference-while young people wait for mental health services, SHAPE equips them with strategies to set personal goals, regain confidence, and improve their overall well-being.

Since its inception in 2021, 96 young people have participated, benefiting from a comprehensive framework designed to promote personal growth and community engagement.

Diversionsary activity programme-

Our Diversionsary Activity Programme provides young people with enriching experiences designed to foster social inclusion, enhance well-being, and create a supportive community. Young people were engaged in a variety of activities, including Bushcraft skills which connects them with nature, overnight camping, fitness sessions, arts and crafts, animation, cycling, Pickleball, dance, and filmed discussions on mental health. The programme particularly welcomed young people with additional support needs, such as Autism, ensuring they could interact safely and meaningfully within their communities.

This initiative has been instrumental in breaking down barriers associated with stress and isolation, empowering young people to build confidence and resilience in a supportive environment.

Programme Delivery

We operate a structured weekly schedule, offering:

Three youth clubs per week - promoting engagement and community spirit.

Two streetwork sessions per week - reaching out to young people in their own spaces.

One media and film group per week - encouraging creativity and self-expression.

Two Pickleball sessions per week - promoting physical activity and teamwork.

One dance session per week - building confidence through movement and rhythm.

Seasonal Initiatives

In addition to our weekly programme, we host seasonal activities to ensure sustained engagement and support:

Easter programme - engaging 112 young people.

Summer programme - reaching 360 young people.

Autumn programme - involving 60 young people.

Addressing Essential Needs

The ongoing challenges of food and fuel poverty, coupled with the rising cost of living, remain critical concerns for young people and their families. We actively seek funding to provide necessary support during these unprecedented times. Through the dedication and expertise of our committed team, demand for our services has significantly increased.

We are grateful to Cash for Kids for their invaluable support in funding essential provisions, including food, clothing, and toiletries. Their contributions have enabled us to meet the fundamental needs of young people, ensuring inclusion during Christmas, Easter, and summer holidays. Over the past year, young people received vouchers towards basic essentials, food and clothing, reinforcing our commitment to providing consistent and meaningful assistance. Parents received support for fuel top ups to get them through the cold winter nights.

By collaborating with external agencies and funding partners, we continue to make a profound difference in the lives of young people and their families, ensuring they feel valued, supported, and empowered.

Easter 2024- Launching 2024-25 with Engaging Activities

We commenced the 2024-25 programme with an exciting Easter initiative, allowing young people to choose their own schedule of activities. The programme featured a diverse selection of fun days with 112 young people participating

Streetwork Programme Update

At the start of the year, the Detached Youth Work/Streetwork team was actively engaging with young people across Drumchapel. However, by June, rising tensions within the community due to gang-related conflicts necessitated a reassessment of operations. Prioritising staff safety, the Streetwork programme was suspended to ensure the wellbeing of both team members and the wider community as advised by Police Scotland.

Employability and Training Programme - Impact and Outcomes

The Pathfinder Programme, delivered by our partners DRC Youth Project, continues to provide vital employability and training opportunities for school leavers across North West Glasgow. G15 actively refers young people to the programme, ensuring they receive tailored support in their transition to employment.

To further enhance opportunities, DWP hosts employability days at the G15 base, bringing together young people aged 17-25 to explore available services within the community. G15 remains committed to securing relevant courses that align with young people's aspirations and career goals.

Summer Fun Days - summer programme - Bringing young people together for fun and joy

This summer, the G15 team embraced the sunshine, creating fantastic opportunities for young people to connect and enjoy a variety of activities. A total of 360 young people participated in our vibrant Summer Fun Days, engaging in everything from trips outside of Drumchapel, guided red bus tour of Glasgow, featuring visits to the Transport Museum and Kelvingrove Museum to Tennis, Pickleball and cinema trips. Other activities have included gaming days, a 12-mile walk along the West Highland Way, Top Golf and trampolining.

For some, the chance to simply catch up with friends was just as valuable as the activities themselves. The day concluded with a relaxed picnic in the park, where young people enjoyed ice lollies and a classic chippy to round off a memorable experience.

Group Work - The Core of G15 Youth Project Scio

At G15 Youth Project Scio, we are deeply committed to ensuring that young people have a voice in shaping their own experiences. As a youth-led organisation, we rarely simply organise activities and hope for participation. Instead, we actively encourage young people to take the lead, forming their own groups, planning activities, and taking ownership of the project with our support.

Our creative group, meanwhile, is developing key media, film, and photography skills-including interview techniques. A standout achievement of this initiative is Drumchapel TV, where young people showcase their work on YouTube. Their projects have tackled pressing local issues, such as street lighting, knife crime, and interviews with influential figures-including First Minister of Scotland, John Swinney.

Drumchapel High School

For many years, we have maintained a strong presence in Drumchapel High School, recognising it as a valuable opportunity to connect with young people who may not engage with our services elsewhere. Through lunchtime outreach and specialised workshops, such as the No Knives, Better Lives program we strengthen relationships, provide support, and address key youth concerns.

Working closely with the school's youth work team, campus cop, and young people referred from the Alternative Curriculum (AC) group, we foster meaningful engagement that leads to positive change.

One-to-One Support

Providing direct, individual support is a core aspect of our work, ensuring young people receive the guidance they need in various areas, including poverty, education, employment, domestic abuse, physical and mental health, sexual health, housing, parenting, and relationships with family and friends. When more specialised assistance is required, we help connect young people with appropriate services such as counselling, suicide intervention programs, men's health groups, and youth health services.

While many funders still require us to record gender as male or female for reporting purposes, we fully respect each young person's right to self-identify. In all our interactions, we honour their chosen pronouns and identity.

Networking & Community Involvement

At G15, networking is a vital tool for fostering collaboration, sharing knowledge, and building strong support systems among individuals and groups with common interests. Staff actively participate in most local networks and hold positions on the boards of several other organisations, contributing to strategic decision-making and community development. Young people attend and shadow the staff.

G15 takes a solution-focused approach, ensuring that young people are actively involved at every level of decision-making, driving meaningful transformation in their communities.

Our small but dedicated team carries out an incredible amount of positive work, continually supporting and encouraging young people and local residents to engage in community initiatives. Their efforts are truly commendable.

G15 and Christmas

In 2024, G15 proudly led the Drumchapel D70 celebrations, bringing festive joy to the community. This year, we hosted the spectacular 'Winter Wonderland,' where 400 children enjoyed a magical visit to Santa's grotto before stepping into a beautifully decorated wonderland filled with enchanting characters. Willie Wonka and his chocolate factory did not disappoint. Thanks to the hard work of local young volunteers and local residents every detail was crafted to create an unforgettable experience.

The event eased financial pressures for families who may have struggled to afford such activities, offering a joyous escape for both parents and children. Over two days, we welcomed 1,924 visitors, fostering a sense of togetherness and celebration. Thanks to funding from HSCP, each child received a meal upon arrival, and parents had the chance to win an air fryer in a free prize draw. We are incredibly grateful to the 25 young people from G15 Youth Project who volunteered their time to ensure that every child had a magical Christmas.

Through the dedication of our funders, partner agencies, and supporters, G15 Youth Project continues to be recognised as a leading provider of essential services for young people. Our thanks go to everyone who has contributed to our ongoing success.

The organisation continued to develop this priority and worked to develop a formal and structured approach to staff development and training.

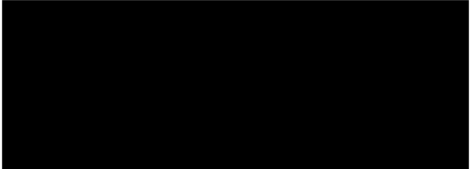

1. ACCOUNTING POLICIES

BASIS OF PREPARING THE FINANCIAL STATEMENTS

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) "Accounting and Reporting by Charities: Statement of Recommended Practice applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015)", the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Charities and Trustee Investment (Scotland) Act 2005. The financial statements have been prepared under the historical cost convention.

INCOME

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

EXPENDITURE

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Grants offered subject to conditions which have not been met at the year end date are noted as a commitment but not accrued as expenditure.

TANGIBLE FIXED ASSETS

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

Improvements to property	- 10% on cost
Equipment	- 25% on cost

TAXATION

The charity is exempt from tax on its charitable activities.

FUND ACCOUNTING

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.
