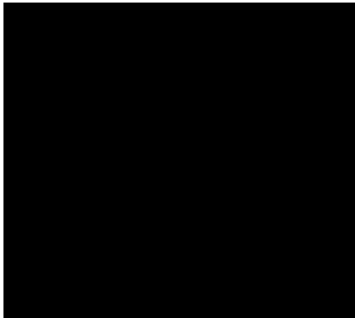

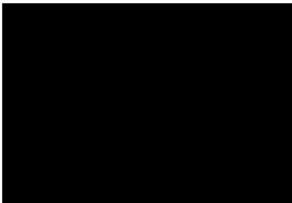

Garve Public Hall is a charitable unincorporated association and the purposes and administration arrangements are set out in our Constitution.

Our purposes, as recorded in our Constitution are to administer the affairs of the Village Hall, to conserve and improve amenities provided by the Hall in the best interests of the community.

Chairperson's Report

I would like to begin by expressing my sincere thanks to the Trustees and all the local volunteers who continue to dedicate their time and energy to supporting the running of Garve Public Hall. Your commitment is vital to the continued success of the hall, and we are truly grateful for your efforts.

Following the recent refurbishment, I am pleased to report that all snagging issues have now been fully resolved. The upgraded facilities continue to function well and meet the needs of our users.

This year, the hall has seen steady and diverse use. Core local bookings remain strong, including the Art Class, Knit and Natter group, circuit training sessions, and regular use by Strathgarve Primary School. We are also pleased to support activities organised by the Garve Events Group, including the well-attended monthly craft fair and the festive Christmas lights switch-on event.

One of the highlights this year was hosting our first Christmas Lunch, which proved to be very popular and well received by the community.

In addition to community use, we have also gained valuable income through a number of external bookings, which helps us ensure the hall remains financially sustainable.

Looking ahead, we are currently in the process of finalising negotiations with the Development Company regarding the shared use of the car parking area adjacent to the hall. We are optimistic that a positive agreement will be reached that benefits both the hall and the wider community.

Thank you once again to everyone who contributes to the success of Garve Public Hall. Your support ensures it remains a welcoming and well-used facility at the heart of our community.

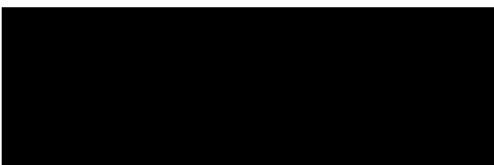
Trustee remuneration and expenses

Recruitment and Appointment of Trustees

Independent examiner's statement

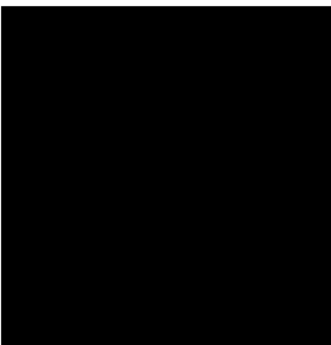

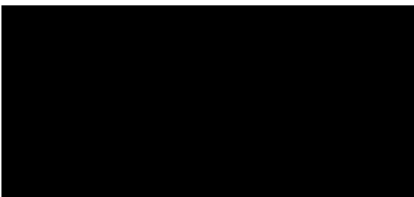
