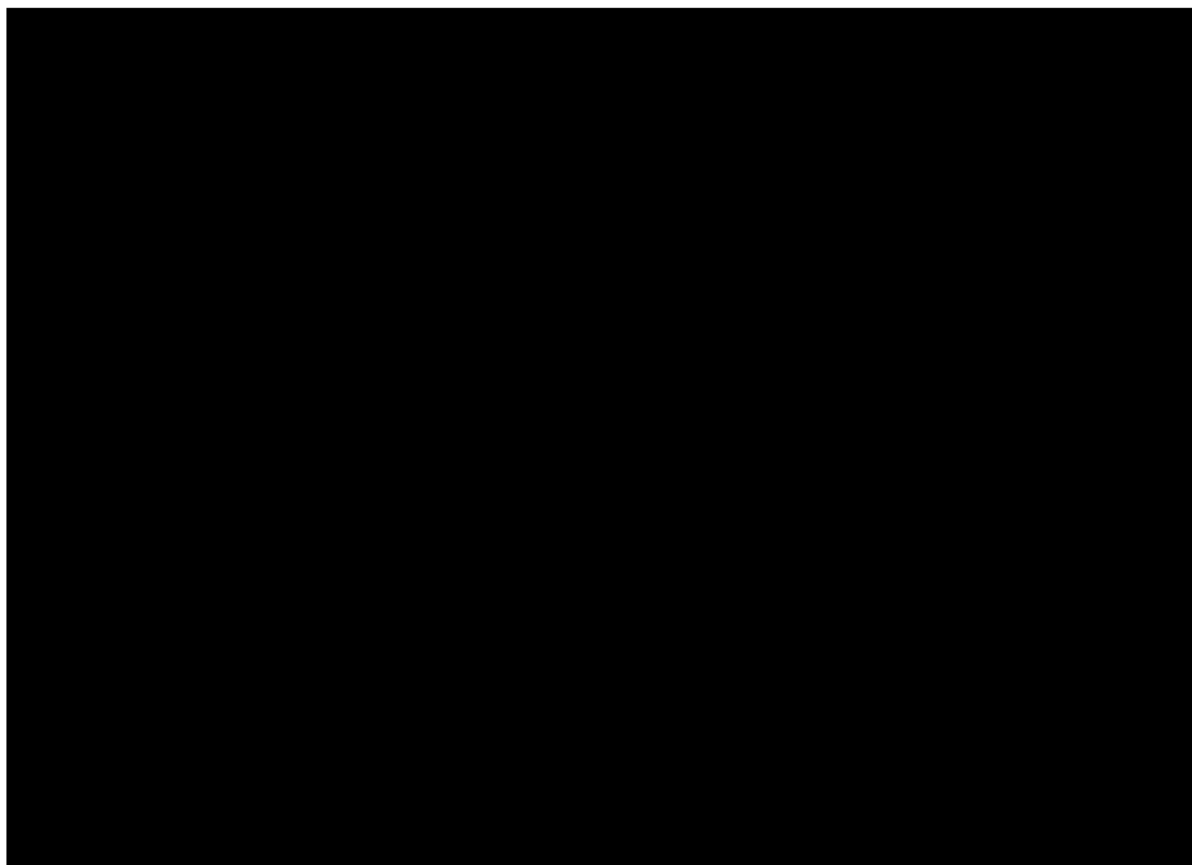



## **Scottish Centre of Tagore Studies**

### **Report of the Trustees for the year ended 30th September 2024**

#### **Introduction**

The trustees present their second annual report and accounts for the year ended 30 September 2024. The legal and administrative information given on page 1 forms part of this report.

#### **Objectives and Activities of the Charity**

Formed on 18<sup>th</sup> September 2020 as a Scottish charitable incorporated organisation, the functions of ScoTs in pursuing its purposes are, in accordance with the principle objects of its constitution:

To build on Rabindranath Tagore's legacy and maintain a continuum with his vision through an exchange of ideas, sharing information and knowledge and developing a research institute.

To support a centre as an international hub for connecting scholars and artists globally dedicated to working with the ideas and work of Rabindranath Tagore and his circle and those who continue to carry forward these ideas through their research and work.

#### **FINANCIAL REVIEW AND RESERVES POLICY**

The charity began its year with the startup sum of £920 in the bank, to which receipts of £21,820 were added, making £22,740 available. Payments of £7,336 were made within the financial year, leaving £15,404 to carry forward.

Due to the Tagore Geddes Festival taking place at the end of the financial year, a note has been made of both related payments and grant being settled in the first quarter of the next year.

Donated services and benefits in kind amounted to an estimated £3,300.

The issue of reserves adequate for a cultural charity such as ScoTs will be dealt with in the years ahead.

A full report on the charity's achievements and future plans is given on pages 3 to 5.

#### **RISKS TO WHICH THE CHARITY IS EXPOSED**

The Trustees consider that due to its small size and its simplicity there is no material risk to which it is exposed. The situation will be reviewed periodically.

#### **STATEMENT OF TRUSTEES' RESPONSIBILITIES**

The trustees are responsible for maintaining proper accounting records which disclose with reasonable accuracy at any time the financial position of the charity and which are sufficient to show and explain the charity's transactions and enable them to ensure that the financial statements comply with regulations made under the Charities Act. They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

The trustees are also responsible for the contents of the trustees' report, and the responsibility of the independent examiner in relation to the trustees' report is limited to examining the report and ensuring that, on the face of the report, there are no inconsistencies with the figures disclosed in the financial statements.

### Report of the Trustees for the year ended on 30 September 2024

#### Introduction

The trustees present their third annual report for the year which ended on 30 September 2024.

The legal and administrative information given on p. 1, forms part of the report.

#### Activities and Achievements

A Cooperation Agreement between ScoTs and Swami Vivekananda University (SVU), Barrackpore, West Bengal, India, was signed on 29 September 2023. It was initiated by the introduction of a certificate course in Tagore Studies at SVU.

The Tagore Centre was inaugurated by [REDACTED] on 21 November 2023.

The *Tagore Geddes Festival* was organised in Edinburgh for the first time by ScoTs on the theme: 'Forests are our Future: By Leaves we Live'. It presented a beautiful dance drama, entitled *Palash: Flame of the Forest*, which was developed, composed and performed by a creative team of professional artists and presented on 28 September 2024 at the Tom Fleming Centre in Edinburgh. End of Project report for the *Tagore Geddes Festival* has been submitted to Creative Scotland and IASH and approved and accepted by them.

Funds are being raised for the installation project of a bust of Rabindranath Tagore, sculpted by the renowned Indian sculptor [REDACTED] and donated by the Indian Council for Cultural Relations (ICCR), Government of India, to ScoTs. Funds have been raised so far through crowdfunding organised by the Scottish Association of Bengali Arts and Sanskritik Heritage (SABASH) for ScoTs. Donations received so far through the crowdfunding set up by SABASH, amount to £4000 approximately. The money is being collected to cover the professional installation cost of the Tagore bust, which is projected to be in the region of £10,000.

### NOTES TO THE ACCOUNTS

For the year ended 30 September 2024

1. **Basis on which accounts have been prepared**  
From date of formation, 18th September 2020, the accounts have been prepared on the receipts and payments basis.  
  
The charity is dependent on donations, service benefits in kind, and sponsorship funding for its charitable activities.
2. **Taxation**  
As a registered charity, the society is exempt from income and corporation tax to the extent that its income and gains are applicable to charitable purposes only. Value Added Tax is not recoverable by the society and is therefore included in any relevant costs.  
If upon winding up or dissolution of the charity there remain any assets, after the satisfaction of all debts and liabilities, the assets represented by the accumulated fund shall be transferred to some other charitable body or bodies having objects similar to those of the charity.
3. **Remuneration of Trustees**  
The trustees manage the trust in an honorary capacity, with neither fee nor round-sum general expense allowances.  
The value of services donated in kind by trustees is conservatively estimated.
4. **Endowment Funds**  
The charity had no endowment funds in the year ended 30 September 2024 nor in the year ended 30 September 2023.
5. **Tagore - Geddes Festival costs**  
This festival took place from 28th to 29th September 2024, in the final few days of the charity's financial year. Consequently the majority of costs relating to it were settled in the first quarter of the financial year following.

## **Independent Examiner's Report to the Trustees of the Scottish Centre of Tagore Studies - ScoTs**

I report on the accounts of the charity for the year ended 30th September 2024 which are set out on pages 6 and 7.

### **Respective responsibilities of trustees and examiner**

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006. The charity trustees consider that the audit requirement of Regulation 10 (1) (d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44 (1) c of the Act and to state whether particular matters have come to my attention.

### **Basis of independent examiner's statement**

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit and consequently I do not express an opinion on the view given in the accounts.

### **Independent Examiner's Statement**
