Organisational Structure

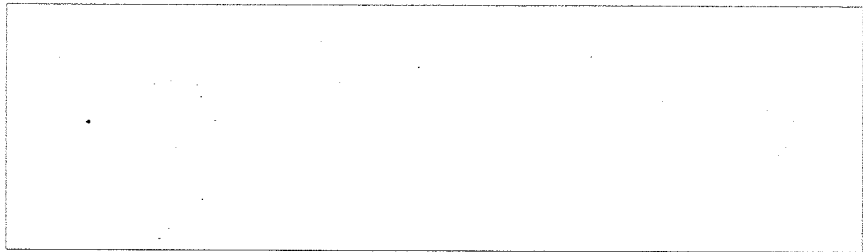
Governance of the Charity is vested in a Board of Trustees (the "Board") elected by members at Annual General Meetings. The Trustees are subject to re-appointment on an annual basis by members at the AGM. After serving the maximum consecutive 9-year period, a Trustee must stand down for a full year before being eligible for re-election.

The minimum number of charity trustees is 3; the maximum number of charity trustees is 7.

The Board of Trustees meet on average 6 times each year. Minutes of meetings and supporting documentation are maintained. Under the auspices of the Board, the day to day management of GUSC is under the direction of the Committee of Members (the "Committee") who shall be elected/re-elected by members at AGM on an annual basis. At least 2 trustees will serve on the Committee and regularly attend Committee meetings. On average the Committee meets 18 times per year. Minutes of meetings and supporting documentation are maintained

Community Partners GUSC has strong partnerships and regular interaction with the Camanachd Association (Shinty's Governing Body), Glenurquhart Rural Community Association, the Glenurquhart Community Council, the Glenurquhart Highland Games Association, Glenurquhart High School and the Glen Albyn shinty association.

- Share facilities, infrastructure and organisational capability with other sports and community organisations to the overall benefit of the community of Glenurquhart.
- Ensure, as far as practicable, equal opportunity for attendance at and safe participation in the sport for members throughout the course of each year.

GUSC is wholly reliant on volunteers for the organising of activities associated with the sport and to individuals and local businesses for financial support through donations and fundraising events.

Likewise routine and annual maintenance of the Blairbeg grounds and clubhouse is carried out in the main by volunteers.

Membership is open to anyone in the local community and beyond, who supports the aims and objectives of the Club. Any member, 16 years or over, is entitled to vote on any motions put forward to the membership at general meetings including the Annual General Meeting.

Achievements and performance

Summary of the main achievements of the charity during the financial period

Membership

GUSC ended the Charity year with 90 adult members (16+) and 87 junior members. 35% of the overall membership was female.

Participation in Competitions

Glenurquhart fielded teams in all levels of competitions for Adults, Juniors, Male and Female .

The men's first team had a disappointing season in a competitive National League but the good performance of the young players in the second half of the season bodes well for the future.

The Men's second team worked hard towards the end of the season to retain our position within North Division 1 for season 2026, They also reached the semifinal of the Scottish Junior Competition , Sutherland Cup, but lost out to Kinlochshiel in a tight game at Invergarry.

The 3 day Youth summer "camp" took place in July at Blairbeg Park.

This event is open to for all local primary school children in Aird and Loch Ness . It was oversubscribed and well attended with players coming from Glenurquhart, Strathglass, Lovat, Beaully and Inverness.

Our youth teams had successes at all ages with the U17s reaching the final of the Mactavish Cup although an excellent Newtonmore team ran out winners on the day. The u14s had a good run in their league competitions.

In mid-July, 4 youth players attended the National Player Development Camp at the new location of Glenalmond College.. Alfie Macleod was player of the camp, standing out from the 80 or so players who attended.

Three of our players were chosen for the Scotland U-17s tour to Ireland; namely Alfie Macleod, Daniel Maclean and Doug Brockie.

In addition, Charlie MacLeod was selected for and played in the U21 North Area team who prevailed over the South Area team.

The Women's first team struggled to retain a foothold in the Premier league but the second team remained buoyant in the North 2 League and ran out winners with a 3 point margin. Young Rowan Brockie was yet again top scorer in her league. The girls u14 teams also had some good outings and high placed finishes. One of our most consistent senior players, Hazel Hunter , was selected to play for Scotland against Ireland at the Bught Park, Inverness in later October,

Community Partnerships

Club Minibus - has now been relocated to the High School to be kept adjacent to the School minibus. Both buses are being used extensively by several local community organisations subject to prior booking and driver vetting.

This has been achieved by significantly strengthening our partnership ties with Glenurquhart High School

Old Shop Site, Balmacaan Road, Drumnadrochit

GUSC in partnership with Glenurquhart Rural Community Association, Glenurquhart Rugby Club and Glenurquhart Football Club , have succeeded in a bid to the Scottish Land Fund for a grant to assist in the outright purchase by the Community of this plot adjacent to Blairbeg Park for a health and wellbeing centre. The legal details and land transfer remain to be finalised but initial plans have been drawn up for scoping the size , shape and cost of the required facilities.

Financial review

GUSC (SCIO) is a volunteer lead organisation with no employees and hence our reserves requirement is relatively modest.
For the sake of good order, it is the intention of the Trustees to retain sufficient funds in the clubs accounts to cover the recurring annual fixed costs and regular services for the forthcoming season without any immediate requirement to fund raise .
For season 2025 services provided on a demand basis are for laundry , clubhouse cleaning and perimeter grass cutting which, on average , amount to £1500 in total. The recurring predictable costs for competition entries, minibus insurance , utilities, minor maintenance, property & liability insurance currently amount to approximately £5000.
Hence our 2025 reserves Policy was therefore to retain a minimum of £9000 in our accessible accounts at year end.
However, as a result of increased costs in all areas and particularly in insurance products and utilities, we will be monitoring our fixed costs carefully during 2026

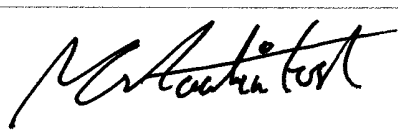

Participation in Competitions

Glenurquhart fielded teams in all levels of competitions for Adults, Juniors , Male and Female and completed all games for which we were eligible.

The men's first team experienced a challenging season in Shinty's Premiership and the majority of results went against them although mostly by narrow margins . As a consequence relegation back to the National Division is now inevitable but the improving performances of the younger players in the second half of the season bodes well for the future.

The second men's team also had a difficult time in the very competitive North Division 1 league but have done well enough to avoid relegation. Once again, the younger players have brought both energy and quality to the team performances.

Given the emerging prominence of younger players in the senior teams , it is no surprise that our under 17 team reached the semifinals of the junior Mactavish cup and decisively picked up the Mowi London Shield league trophy at the end of the season (2/11/24)

Likewise the U17 Development Team, which also includes on some of our young women players, won the WJ Cameron Trophy on 27/11/10 following a league and knock out competition.

The women players were in action in the National Senior League, the North 2nd Division and the U14's "Round Robin" competitions. The National Team consolidated there position mid table in the league and the North 2 team did us proud by coming top in a hard fought League which went to the final game to be decided. It would be amiss not to mention the outstanding individual achievement of U14 player [REDACTED] who scored 27goals in 18 games in the North 2 league placing her as top scorer in that league.

For representative games ,Glenurquhart had two under17 youth players selected to play for a Scottish select in Ireland. In addition 5 senior women and 6 junior women were selected for the East and west representative games held annually in Oban.

The 3 day Youth summer "camp" took place in July at Blairbeg Park. This event is open to for all local primary school children in Aird and Loch Ness . It was oversubscribed and well attended with players coming from Glenurquhart, Strathglass, Lovat, Beaully and GMA.
