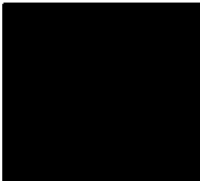

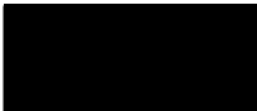
Trustee's responsibilities

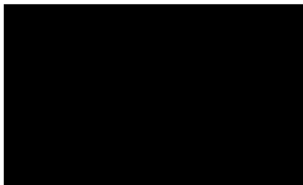
Independent examiner's statement


