- 5 We continually post and update our social media platforms. Facebook, LinkedIn, WhatsApp, existing known services with information about support opportunities which are informative and are open to all of our local community.
- 6 Actively continue to provide upcoming events and activities to all and to share the particular event afterwards to encourage others that may find themselves in need of social interaction and/or support, thus promoting good wellbeing for the individual, family and our society.
- 7 Most of our volunteers are previous service users that have been happy and comfortable within our setting and surroundings.
- 8 We have PVG checks for all volunteers and training officers. We also offered first-aid training and further support to members. Often suggesting that there are other available services and support available, signposting to vital organisations within our community that are well known to us through our own experiences.
- 9 We continue to collect furniture, clothes, books, toys and equipment to move onto anyone that may need support with these things. We never charge for our services but we do promote that any donations would be welcome. We have made connections with local shops like Asda, Lidl and Tesco for those desperate in need.

ACHIEVEMENTS AND PERFORMANCE

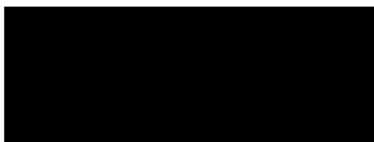
1. Since 2022 we have provided the following services in conjunction with Go Kids, Wishaw. 12 months pre-

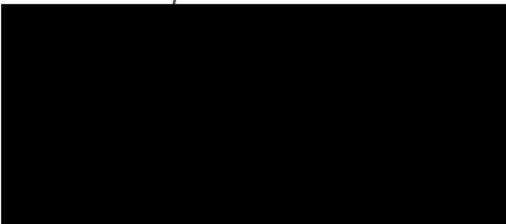
Basis of the independent examiner's report

My examination was carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeking explanations from you as the Trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

Independent examiner's statement

- I have completed my examination. I can confirm that no matters have come to my attention in connection with the examination giving me cause to believe that in any internal respect:

I have no concerns and have come across no other matters in connection with the examination to which attention should be drawn in this report in order to enable a proper understanding of the accounts to be reached.



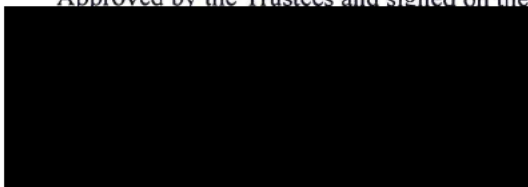
