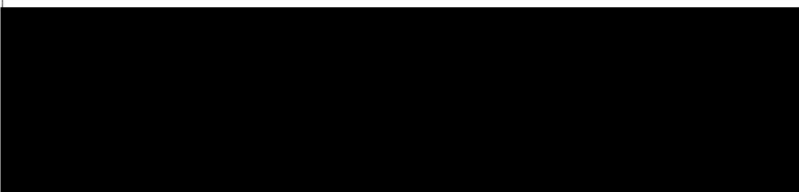

Summary of the main achievements of the charity during the financial period

Through our partners in Honduras and El Salvador, we have achieved the following during the financial period:

HONDURAS

We have enabled 84 young people and farming families from the indigenous Lenca region of western Honduras to develop their education and income-generation opportunities and thereby build a more secure and hopeful future for themselves.

EL SALVADOR

We have ensured the safety and wellbeing of two female refugees seeking asylum in Spain by providing subsistence grants whilst they obtain the right to work and support themselves.

Our policy on reserves is to hold sufficient funds to cover any financial commitments that we expect to disburse in the coming 3-6 months. Any funds needed beyond that period are expected to be donated by ourselves from our private resources, since we are main donors of the Tigh Sgoile Trust.
