As women migrants they often face challenges based on various factors such as their race, ethnicity, educational status, disability, religion, sexuality, immigration status which compounds the inequalities that they may already be experiencing based on their gender. In addition, the women also face inner challenges such as low self-esteem and confidence, poor mental health, and physical health too. At Sharpen Her, we work towards mitigating as many of the consequences of these challenges within our capacity as much as we can. We share information, signpost, collaborate with other organisations, offer emotional and practical support, connect women socially using their skills assets, knowledge

ANNUAL REPORT (2024-25)

The Annual Report for 2024-2025 ended with a call to action to our members:

- *Join us as volunteers*
- *Actively engage and put your skills into practice*
- *Help in improving our social media presence – we are currently on Facebook, LinkedIn. We also have X and Instagram which are not active.*
- *Spread the word in your networks*

Perhaps that could also make for a start for this year's report. Where are we? Where is Sharpen Her today? With a growing membership of 260 plus, there are so many things we can celebrate as we look back at the past 12 months.

We have made quite a number of strides, yes, but we are not going to rest on our laurels. We believe there is still room for growth. Quite a lot has happened, and it has all supported our overarching aim of supporting the integration of African women by building their capacity, confidence, and resilience.

We have seen more engagement, more women stepping up as volunteers.

Women engaging more, and putting their skills to use, sharing skills with others.

Women are spreading the word about our work in different platforms and forums.

We can also celebrate:

Increased partnership working such as:

- Collaborations with educational institutions such as Glasgow Clyde College, Glasgow University, and the University of Strathclyde. We have received student volunteers, some of whom are still volunteering for us to date.
- Employability agencies such as Smart Works and Dress for Success Scotland who provide interview preparation, coaching and provision of interview clothing for women going for interviews and further support after women get the jobs. The two organisations were kind enough to donate items of clothing to our members.
- We brought together several organization for a learning event to share best practice on Working with New Scots. The event was attended by Maryhill Integration Network, Police Scotland, Shelter Scotland, Scottish Refugee Council, Tricky Hat, and Shine Your Light Community. The events received positive feedback, and we hope to hold more of such to share learning.

- We worked with Pilotlight on their Make an Impact project where we were connected to Arup an engineering company where their staff volunteered to support our business operations. They developed a communications strategy for us and beyond that, they donated 3 laptops.
- The Home Office National Community Engagement Team, who have been very instrumental in providing our members with information to aid compliance with immigration rules. At the end of 2024, 4 of our members attended the Team's conference which was a testament to the increase in confidence within our membership, especially those who would not normally engage with such a fearsome organization.
- We held an Antiracism consultation with support from Impact Funders and our members made contributions to the proposed Anti-Racism Observatory in Scotland.
- Our members have become Climate Change Ambassadors under CEMVO () where they are building their understanding and capacity to act on issues of climate change.
- We have developed links with Glasgow Life who granted us £400 to start a walking group. Not only that, one of our members underwent training as a walk leader and will be supported to lead walks to support active life. Women are reporting feeling better mentally due to the walking. Women also took part in cycling lessons delivered by Women on Wheels and that was followed by Cycling UK giving us a grant to purchase 10 bicycles under their Individual Ownership Fund.
- Continued collaboration with Police Scotland with whom we have had several collaborations such as training their sergeants to understand how best to work with New Scots, funding and event at the DWP offices to support African women to get into jobs and finally we had an International Women's Day event at Police Scotland premises.

Our funders have enabled us to carry out a vast majority of activities through the unrestricted and restricted funds received. We have been able to maintain our weekly support group, which has been a lifeline for many of our members. Sharpen Her office is situated within walking distance of one of the asylum hotels in Glasgow. This has meant that many women living in that accommodation have taken to accessing our service, which is a safe space where they can unwind, relax, and make connections with other women. Many women also find that they can access peer support and information as they engage with our Tuesday group. This service has become a backbone of our work, once a woman engages with this group, they are able to learn more about what else is available to them through Sharpen Her. This can be direct support, whether emotional or a support letter for an application, or signposting to relevant agencies.

During the year we have also been able to run a digital inclusion project funded by The Good Things Foundation. Virgin Money kindly offered their staff and premises to volunteer to offer digital support to our women on a fortnightly basis. We have seen women's confidence in using computers increase and they are able to work at their own pace and according to their identified learning needs. We have been able to continue this digital support well after the funding is finished. We hope to continue as the need still exists.

Within the same lines of digital support, the National Databank through Migrant Help facilitated the distribution on 20 mobile phones to some of our asylum-seeking women.

We continue to run a weekly virtual support group where women come together to connect, learn, and interact. This year, this has been enhanced by the involvement of a student volunteer who has tirelessly facilitated structured sessions where more women are engaging and learning a lot.

We have been able to streamline our communications beyond the WhatsApp group. We have a newsletter with which we communicate with our members which has resolved the challenge of information being lost amid the many messages on our Whatsapp group. We have also introduced signed-up membership, which means we are able to identify who our Bonafide members are amongst the 260 we see on the platform.

We have also fostered integration by creating opportunities where women have accessed spaces which they have not been able to before. Women have been to the Tramway Museum, Willow Tea Rooms, Loch Lomond National Park, and the Red Bus Tour which enabled women to explore several places of interest in Glasgow.

In true Sharpen Her fashion, we celebrated our 6th anniversary with more than 90 women and families coming together to mark the day. We invited a woman who has defied the odds to take a high-flying job in the financial sector. Using role models in this way has had an impact on women who may have otherwise lost hope and confidence due to the challenges faced as they navigate the systems on this country.

The journey has not been without its challenges:

- We need staff and volunteers to run the day-to-day operations of the organization
- Our finances though stable have been challenged due to the current funding climate
- We need to build capacity for those carrying out the work, especially in supporting the women.

As we start a new year, we believe that these challenges will be resolved, and we can have more impact on the community.

All in all, 2024-25 was a fruitful year and we are confident that the trajectory will stay on an upward trend.

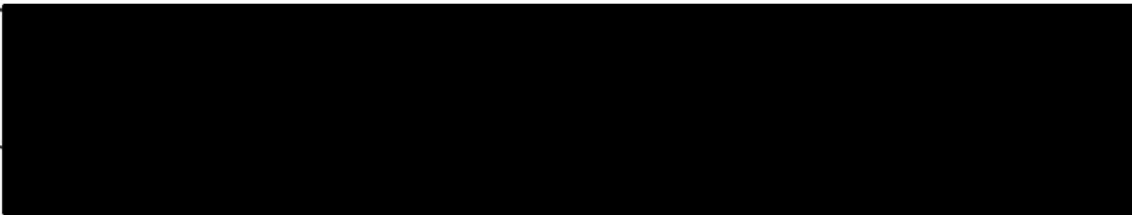

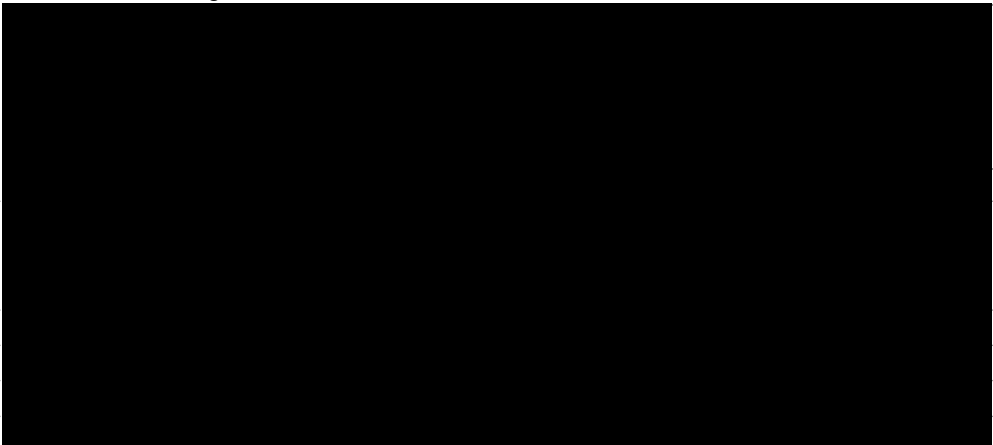
