What the charity does: The main activity of the charity is securing sponsors to fund children in Toowa to attend Toowa Primary School, supporting the costs of the education, food while at school and emergency medical care where required. As the school roll has grown considerably, we have also supported numerous fundraisers to support the development of school estate as well as fund fun and educational activities such as a Christmas party and school trip. Over the year we hold various fundraising activities to raise additional monies for the additional projects prioritised each year.

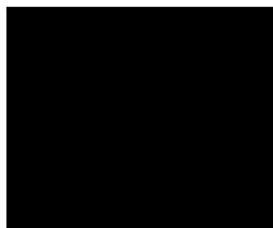

Structure, Governance and Management

Friends of Toowa is a Scottish Charitable Trust with all current trustees named in the 2021 Trust Deed (Appendix One) which outlines the structure, governance and management arrangements for Friends of Toowa. The Trustees support the Chairperson to administer the Trust according to their area of expertise: minutes and record keeping, fundraising, accounting and finance and sponsor/public communication.

Friends of Toowa has no direct employees but a Liaison Coordinator employed by the school is financially supported by the Friends of Toowa.

All income is used to support agreed projects in Toowa that meets the charitable purpose and agreed priorities of the Friends of Toowa.

Objectives and Activities

Charitable Purposes

The advancement of education by providing resources such as pupil sponsorship, books, school fabric and training at Toowa Primary School of Uganda.

The prevention or relief of poverty through direct provision of aid to Toowa Primary School and/or supporting projects of work within Toowa to empower people to generate an income for themselves and/or to relieve the impact of poverty.

The promotion of health and wellbeing of the children of Toowa Primary School actioning medical needs where and when necessary.

Toowa Primary School

Toowa is a small village, located near Lugazi in Uganda. With a population of about 6000 people Toowa has a high percentage of women and children, with the majority living in poverty due partly to the current high levels of illiteracy in the population. Toowa Primary School, founded some 21 years ago by the Lugazi Pentecostal Church, aimed to provide local access to education for the many local children to both reduce the travel by foot for those children attending schools in neighbouring areas and to reduce the many social problems arising from lack of access to education. The school's humble beginnings started with preschool classes only with additional classes and buildings introduced each year.

Capstone Projects initially supported the development of Toowa Primary School as one of several projects but given the growth in the development of Toowa, it was agreed to establish Friends of Toowa as a charity in 2021 with OSCR approval being granted in April 2021.

We remain hugely grateful to all who helped develop Toowa Primary School to the scale we as trustees inherited in 2021.

2024-2025 An Overview

This has been another successful year for the charity both financially and from an achievement perspective. Four meetings have been held by the Trustees.

Progress against agreed priorities is as follows:

1. Sustain key activity.

With a growing number of children and ongoing development of the school estate our Liaison Coordinator is kept very busy, managing the delivery of core roles at Toowa Primary School as well as supporting the wider care and wellbeing of many families in poverty related crisis.

2. Increase the number of sponsored children.

The number of children sponsored grew from 121 to in April 2024 to 130 in March 2025. The sponsorship scheme has remained at £15 per month for the children attending Toowa Primary School, providing the main income source for Friends of Toowa and the sole means of supporting the education and wider welfare support of all the sponsored children.

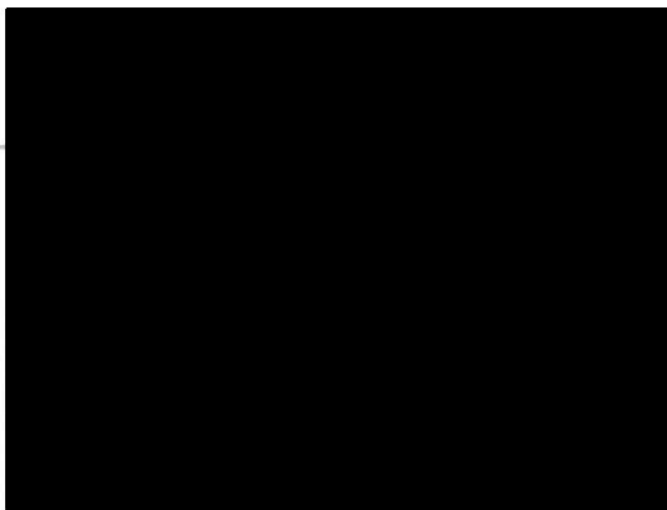
We also have seen some children supported to progress into secondary school. While Toowa does not have a secondary school available yet, a collaboration has been

developed with Hope Christian High School in Lugazi to provide a means of accessing ongoing education supported by sponsors at a cost of £30 per month.

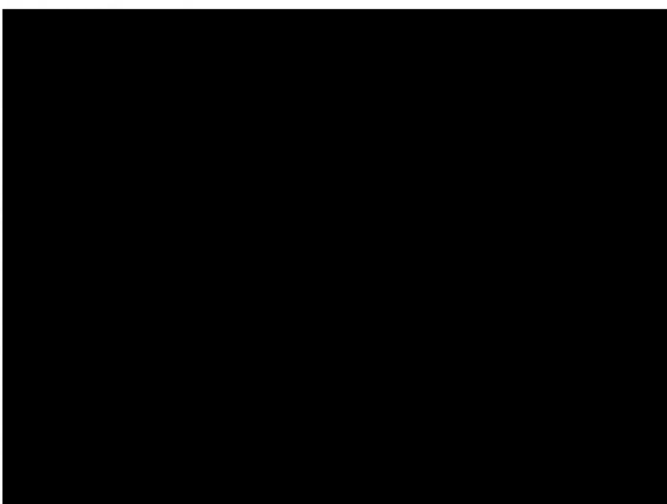
3. Further increase classroom capacity and estate suitability to accommodate increasing school roll.

A priority list for premises development was updated and will be the focus for grant applications and fundraising over the next year or two to realise the ambition. This includes:

1. Building of a latrine block with washing facilities. Identified as a priority last year, ground has been purchased and building commenced with financial support provided by the Rotary Club.
2. Purchase of ground and building of a new boy's dormitory. Fundraising is underway for this development which will be progressed in 2025/2026.
3. Establishment of a well to both pump water to water storage containers and also ensure water supply in the event of electrical failure. This work has been completed.
4. Reinstatement of playground. Thanks to a fundraiser by a local supporter equipment has been procured by the school and awaits purchase of some additional ground to position. It had been hoped to place the equipment over the site of the well but this has been advised against for safety reasons by local engineers.
5. The technical class commenced in 2023/24 was completed and formally opened in March 2025, providing two technical classrooms including a computer room and incorporating a 10,000-litre water collection tank, which has greatly supported access to water within the school estate.



Significant maintenance painting works have also been undertaken this year to maintain the development work progressed over the last 2 years. We are incredibly proud of the development of the school estate in the 4 years the charity has been established and remain ever grateful to all supporters and donations which has made this work possible.



4. Annual school trip accessible to all children.

A school trip held on 19th July 2024, supported financially by Friends of Toowa, for all P7 pupils was another great success.

5. Continuation of dental hygiene project.

A further visit by Dentaaid was made in October 2024 with ongoing provision of toothbrushes and toothpaste to promote ongoing dental hygiene.



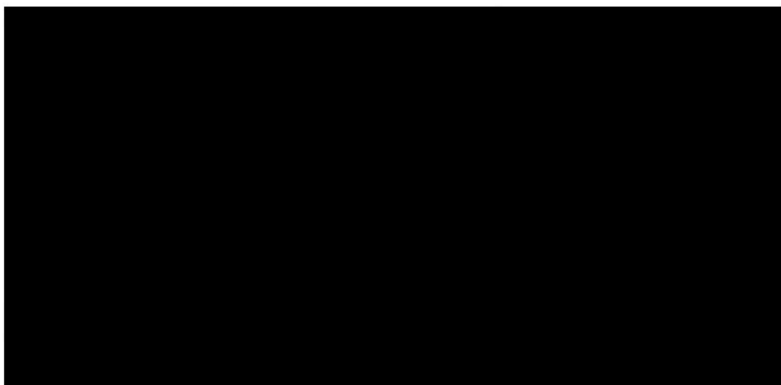
OTHER:

6. Bretherton Youth Group.

Four young members of Bretherton Youth Group set themselves a goal of raising £10,000 to improve the sanitation facilities within Toowa Primary School through the latrine and boy's dormitory projects. As at March 2025 their fundraising total stood at an incredible £6000, with a self-funded trip planned to visit Toowa planned for summer 2025. Quite an incredible achievement which will leave a lasting legacy at Toowa.

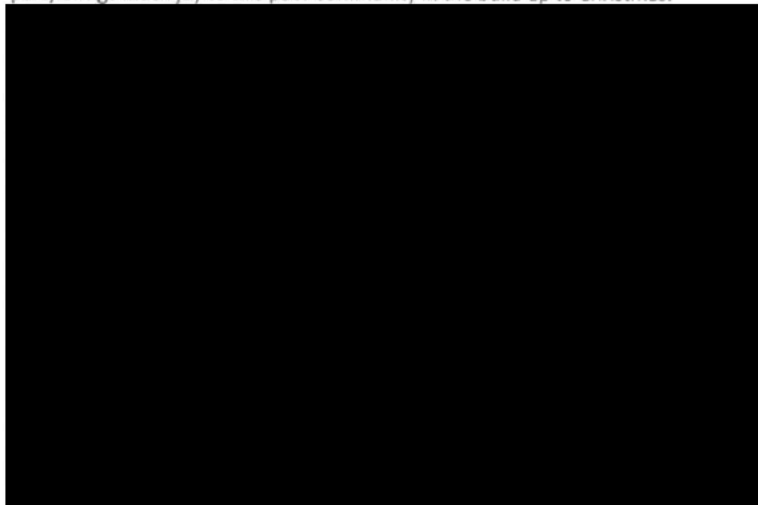
7. **Aberlemno Primary School.**

We were also fortunate enough to be chosen by Aberlemno Primary School to be benefactors of their enterprise project in 2024/2025. While their fundraising was still ongoing as at April 2025, they had already run numerous projects including a 2025 calendar, coproduced with pupils of Toowa Primary School.

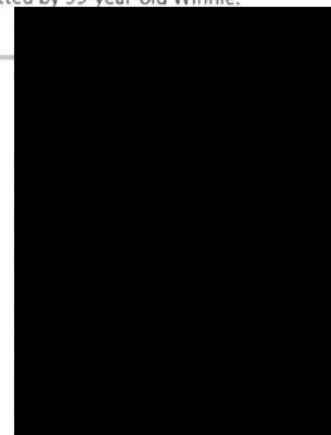


8. **Christmas Party.**

A party was held in December 2024 thanks to the generosity of our supporters. The party brings much joy to this poor community in the build up to Christmas.



9. **Ongoing provision of support and help in kind** e.g. dresses and knitting. Special thanks to our amazing band of knitters and seamstresses for their ongoing support. This lovely cardigan was knitted by 99-year-old Winnie.



10. **Fundraising:**

- A team of 5 walkers took part in Aberdeen Kiltwalk in June 2024.



- A very successful Christmas fair was held in Kirriemuir
- A supporter took part in the Ride the North cycling event locally to purchase new play equipment for the schools planned refurbished playground.
- Supporters ran a local half marathon to purchase a computer for the school library.

- We were extremely fortunate to secure a regional Rotary Grant and a commitment of additional local Kirriemuir Rotary support to support the latrine and boy's dormitory projects. With an initial hugely successful afternoon tea held in March 2025 by Kirriemuir Rotary raising £1000 for Friends of Toowa. This funding will be used to develop the latrine in the first instance, given the importance of sanitation.

Priorities we could not progress this year which we hope to progress when capacity allows are:

- Establish a holiday club to ensure the most vulnerable children receive food and access activities during school closures.
- Develop a business plan for the establishment of a secondary school for the children of Toowa.

Looking to the future with a growing school roll we also know we need to prioritise:

- Construction of additional classrooms.
- Provision of additional computers.
- Development of a sick bay/health clinic within the school.

To progress with the build of the boy's dormitory and additional classrooms we will need to expand the school footprint with the purchase of additional land.

Our priorities for delivery in 2025-2026 to continue to meet the needs of our charitable purpose, are all funding dependent and include:

1. **Sustain existing activity and levels of sponsorship**, increasing the numbers of sponsored children attending school if possible.
2. **Continue to deliver projects both as a charity and through collaboration with partners which supports the health and wellbeing of all children attending Toowa Primary School**, including dental hygiene, and meeting immediate healthcare needs for individual children.
3. **Continue to develop and expand the school estate including:**
 - **Build the latrine block and boys dormitory**, which includes the purchase of land to enable this to progress.
 - **Reinstate playground**. It is hoped that space for this will be included in the above land purchase.
 - **Upgrade water system** including UV purification to improve health and safety within the school.
 - Purchase additional computers.
4. Continue to support an annual educational trip for P7 pupils aligned to curriculum.
5. Continue to support a Christmas party at the school.

Section C Notes to the Accounts

C1 Nature and purpose of funds (may be stated on analysis of funds worksheets)

The charity began its accounts with the RBS from 1st August 2021. Previous to this date the finances of the charity were hosted by the charity Capstone Projects.

The backbone of funding for the charity comes through individual sponsorship of children at Toowa Primary School of £15 a month. At the end of March 2025, 130 children are sponsored (an increase of 7 children from last year). Additional funding comes from the sponsors for specific needs of the children and families they sponsor, from single donations and fundraising activities.

The purpose of the funding is for:

- The advancement of education by providing resources such as pupil sponsorship, books, school fabric and training at Toowa Primary School of Uganda.
- The prevention or relief of poverty through direct provision of aid to Toowa Primary School and/or supporting projects of work within Toowa to empower people to generate an income for themselves and/or to relieve the impact of poverty.
- The promotion of health and wellbeing of the children of Toowa Primary School actioning medical needs where and when necessary.

The individual sponsorship of the children is unrestricted and can be used for the purposes above as determined by the school leadership team and Trustees working with the Head Teacher at the school in Uganda. Occasionally sponsors may make donations for specific purposes of the child/family they are supporting and these are included in restricted funds. These can include such items as pigs/housing/bedding. Likewise some individual donations and fundraising can be unrestricted but on other occasions specific reasons for donations and fundraising will be made such as for the build of a technical classroom, paving stones or the school Christmas party.
