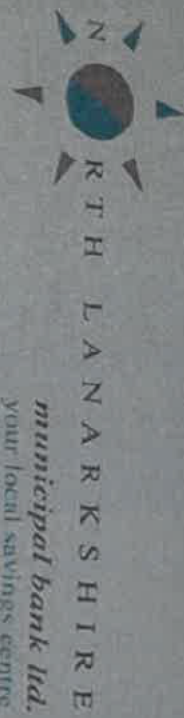

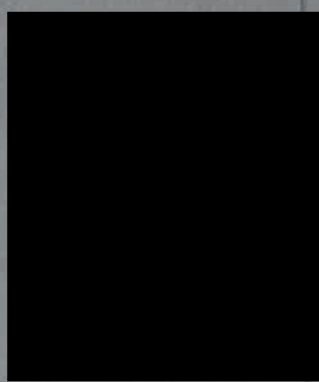
The Bank is conducted and governed by Directors appointed by the Shareholders. Both Shareholders and Directors must be members of North Lanarkshire Council
