Objectives and activities

Charitable purposes	VCT assumed responsibility for the premises at Glenesk Park upon its establishment in June 2021. At that time, the grounds and facilities required significant repairs. The vision was to redevelop the site into a dynamic, multi-purpose, and self-sustaining community hub in Dundee. This hub aims to offer a safe, inclusive, and welcoming space where local individuals, groups, and services can gather and operate at no cost—provided their initiatives align with the needs of the local community, as outlined in the Local Community Plan.
Summary of the main activities in relation to these objects	We have established ourselves as the primary support centre for a local residents group offering the facility at no cost in alignment with our charitable mission. This has created a consistent safe environment where disadvantaged families can gather, socialise and enjoy meals together. Local children have enjoyed Easter, Halloween and Christmas parties, as well as a Christmas fayre full of activities. We have provided warm clothing and household items to local residents in need.

Achievements and performance

Summary of the main achievements of the charity during the financial period

We have provided our facilities free of charge to a local residents group, as mentioned earlier. Without our premises they would have been unable to carry on their invaluable work in our area. Our community kitchen and warm space area is now fully operational and available not only to this group but also to other local organisations that support the disadvantaged. Over the past year we have focused on building relationships with local businesses and potential funders to help drive the charity's growth. We are actively seeking new board members to support the charities future development and have established a working committee to organise events in the upcoming financial year. Additionally, we are in discussions with other groups to utilise our premises at no cost.

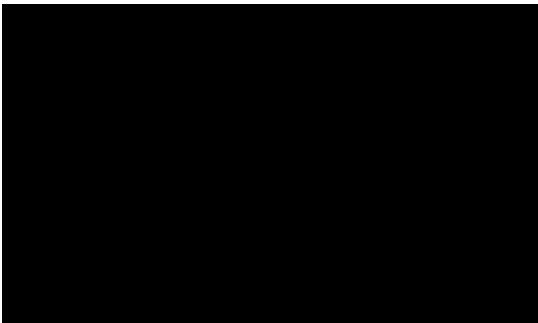
