The event convened women from diverse backgrounds to reflect, connect, and celebrate the depth of knowledge, experience, and leadership across the community. Through discussions on reclaiming women's spaces within the masjid, faith-driven activism, and building resilience through faith, the conference highlighted and amplified the voices, insight, and impact of Muslim women. 200 women joined for this full day conference from all around the UK.

In 2024 we were consulted on and took part in the UK launch of 'Our British Mosque' by Open My Mosque in the Houses of Parliament which had a UK wide perspective with similar findings to our report. It allowed for us to grow our network of support and connect with other stakeholders.

We began discussion and research for our Muslim Female Scholarship conference. Our report found that women found it difficult to access female faith leadership for guidance, advice and counselling and the Conference is going to platform female scholarship and faith based initiatives and ideas from around the UK.

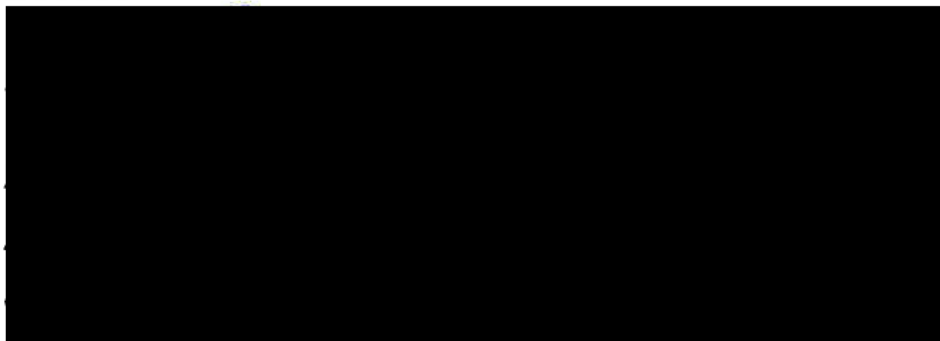

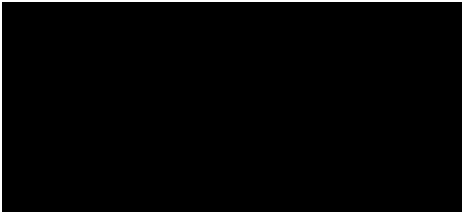
