The trustees present their annual report and financial statements for the year ended 31 March 2025.

St Andrew's Mar Thoma was incorporated as a Scottish charity (SCIO) on 13 July 2021. The Church began as a prayer group then became a parish. The income held by the parish was donated to the SCIO.

The financial statements have been prepared in accordance with the accounting policies set out in note 1 to the financial statements and comply with the charity's constitution the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 (as amended) and "Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102)" (effective 1 January 2019).

#### Objectives and activities

The organisation's purposes are

- the advancement of religion, specifically the Christian faith, in accordance with the traditions of the Mar Thoma Syrian Church of Malabar and consistent with: - The Christian Bible - Declaration and Rules of the Mar Thoma Syrian Church of Malabar
- Provide its members with regular Christian worship services, in accordance with the traditions of the Mar Thoma Syrian Church of Malabar
- To provide pastoral care and organize activities to promote the spiritual life of its members and wider community
- To make voluntary contributions for evangelistic and charitable work in the United Kingdom and abroad - especially India
- The Charity may participate in collaborative programmes with other Churches with which it has communal relationships and also participate in all acceptable ecumenical relationships as a full member of the World Council of Churches (WCC) and Churches Together in Britain and Ireland (CTBI)

#### Achievements and performance

On behalf of the executive committee, let me present the Annual report for the year 2024-25. Our Parish which started in 2001 as a small prayer group has crossed many milestones since, and we are hoping to continue this growth further in the years coming. We started 24 years ago as a small prayer group and God transformed this humble beginning to a blessed parish named St. Andrews Mar Thoma Church, Edinburgh. Our Prayer group was declared as a congregation in the year 2003 and then elevated to a parish on 1 March 2021, and we have now completed four years as a parish. We are the one and only Mar Thoma Parish in Scotland. We received our charity registration on 13 July 2021 and became Scottish Charitable Incorporative Organisation (SCIO), making us the first Parish in the UK with SCIO or CIO status. Last year our Parish registered with HMRC (His Majesty's Revenue and Customs) enabling us to claim Gift Aid which was another great achievement.

#### Our New Church (St Andrews MarThoma Church, Sheildhill, Falkirk, FK1 2DT)

It has always been our dream to have our own church building, and through dedication and hard work, we have turned that dream into reality. We started searching for a place of worship since 2021 and viewed a total of 10 church buildings and put offers for 6 church buildings altogether. On 8 January 2025, the Building Search Committee found the Blackbraes and Shieldhill Parish Church, owned by the Church of Scotland, which was available for sale. On 12 January 2025 a viewing was arranged and an executive committee held on same day decided to put an offer to the church building within the range of £125,000 to £170,000 after getting approval from the General body. An emergency GB which was held on 19 January 2025 after getting approval from Diocesan Episcopa and GB decided to put an offer with the range of £125,000 to £200,000. During this time, we were able to get in touch with the office bearers of Blackbraes and Shieldhill Parish Church, and we came to know that the congregation was eager to sell the church building to us, as they wished to preserve it as a church and a place of worship. After further consultations with them, we submitted an offer of £95,000 for Blackbraes and Shieldhill Parish Church, located in Shieldhill, Falkirk, FK1 2DT, through Austin Lafferty Solicitors. Our offer was accepted on 13 February 2025, and we received the keys to the church on 28 March 2025. There were a total of 10 notes of interest including ours for this church building but our offer was accepted because the congregation of Blackbraes and Shieldhill wanted to ensure the building continued to serve as a place of worship. This marks a historic achievement for the Mar Thoma Church in Scotland, our very first church building in Scotland. A wonderful gift from God Almighty for us and for future generations. Executive committee meeting held on 22 March 2025 discussed the possibility of having our church consecration on 10 May 2025 (Saturday) and first Holy communion on 11 (Sunday) 2025 after seeking the availability of our Diocesan Episcopa [REDACTED]. The overall responsibility of the arrangement consecration was entrusted to [REDACTED] Secretary and Vice president Mr [REDACTED] as the in charge of public meeting. We express our heartfelt gratitude to our Vicar and President, [REDACTED], our Vice President [REDACTED] and special thanks to our Trustees, [REDACTED] and [REDACTED], for their dedication in managing the finances necessary for acquiring the church building. My sincere thanks to the Executive Committee members and all our parishioners for their unwavering support and hard work in making our dream come true. Without your support, we could not have achieved this milestone. A special thank you to our parish member, [REDACTED] for generously agreeing to build the new Holy Madbaha for our church, and to [REDACTED] for their great commitment and valuable contributions. We also thank [REDACTED] kindly agreeing to undertake the painting work. Special thanks to [REDACTED] for their help in sketching a model for our new Madbaha.

Once again, I extend my deepest thanks to everyone. We are incredibly proud of the achievements God has graciously granted us over the past years. These accomplishments are a direct result of the dedicated and fervent support of our parishioners. As we look to the future, it is our humble wish and prayer to grow spiritually in and through Christ in the years to come.

#### Our Vicar

Our Vica [REDACTED] took charge of the Parish family from 1 November 2022 and has now completed two year and six months of their wonderful ministry here. We are blessed to have [REDACTED] as our new Vicar, his spiritual leadership is a great motivation for us all. We also express our sincere thanks to our Vicar for the valuable service and guidance offered to the general administration of the parish and pastoral care to members. By God's grace Now we have our own place of worship. The Reporting year we have been using St. Mary's Episcopal Church, Dalmahoy as our place of worship on a rental basis. Rev. Christine Downey, who is the rector of this church, has been very helpful. We have been using St Mary's Episcopal Church, Dalmahoy as our place of worship since July 2019. We have had regular Holy Communion service every 2nd, 4th, and 5th Sunday of the Month at 2.30pm at St. Marys Episcopal Church, Dalmahoy. The fifth Sunday service is conducted in the English order, and our Youth Fellowship members assist the Vicar during the service, which helps foster greater involvement of our youth in church activities. At present, we have four prayer groups: Edinburgh, Kirkcaldy, Glasgow, and Aberdeen. Holy Communion is celebrated every second Saturday of the month in Aberdeen for our members residing in that locality.

This year, 11 new members joined our parish. On behalf of St. Andrew's Mar Thoma Church, Edinburgh, I extend a heartfelt welcome to these new members.

On behalf of Executive committee I would like to express our heartfelt thanks to [REDACTED] and office bearers of St.Marys Episcopal church Dalmahoy.

Current reporting year we also used St Machan parish church for six months from July 2024 till December 2024. Thanks to [REDACTED] and office bearers of St Machan Church for their help and support.

This level of reserves has been maintained throughout the year.

The funds at 31 March 2025 are £21,038 which are considered reasonable.

### Gift aid

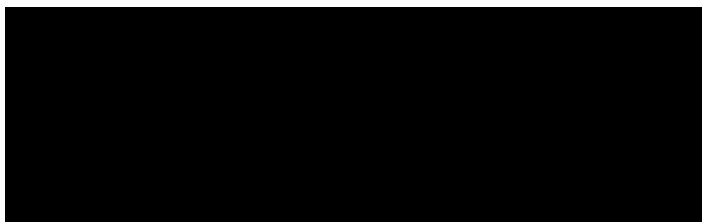
In the reporting year ,we have managed to claim £30,402 as Gift Aid from HMRC.

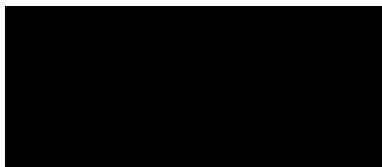
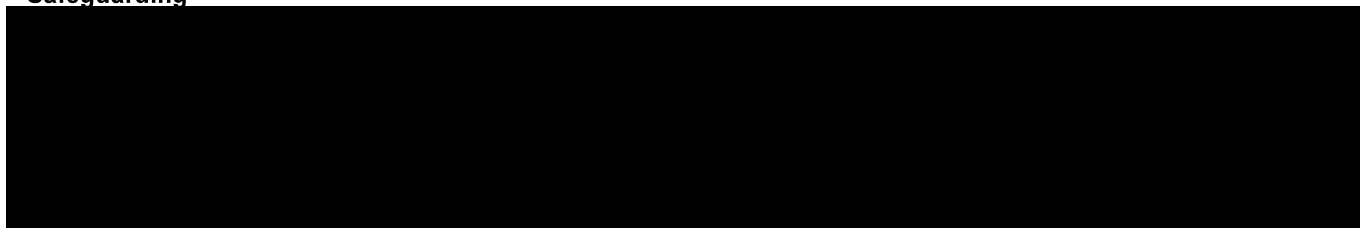
The trustees who served during the year and up to the date of signature of the financial statements were:

I report on the financial statements of the charity for the year ended 31 March 2025, which are set out on pages to 13.

#### **Respective responsibilities of trustees and examiner**

The charity's trustees are responsible for the preparation of the financial statements in accordance with the terms of the Charities and Trustee Investments (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006. #### **Basis of independent examiner's statement**

## NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 MARCH 2025

### 1 Accounting policies

#### Charity information

St Andrews Mar Thoma Church is a Scottish Charitable Incorporated Organisation (SCIO) registered on 13 July 2021.

#### 1.1 Accounting convention

The financial statements have been prepared on the Receipts and Payments basis in accordance with the charity's constitution, the Charities & Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended).

#### 1.2 Charitable funds

Unrestricted funds are available for use at the discretion of the trustees in furtherance of their charitable objectives.

Restricted funds are subject to specific conditions by donors or grantors as to how they may be used. The purposes and uses of the restricted funds are set out in the notes to the financial statements.

Endowment funds are subject to specific conditions by donors that the capital must be maintained by the charity.

#### 1.3 Income

Income is recognised when the charity is legally entitled to it after any performance conditions have been met, the amounts can be measured reliably, and it is probable that income will be received.

Cash donations are recognised on receipt. Other donations are recognised once the charity has been notified of the donation, unless performance conditions require deferral of the amount. Income tax recoverable in relation to donations received under Gift Aid or deeds of covenant is recognised at the time of the donation.

Legacies are recognised on receipt or otherwise if the charity has been notified of an impending distribution, the amount is known, and receipt is expected. If the amount is not known, the legacy is treated as a contingent asset.

#### 1.4 Expenditure

Expenditure is recognised once there is a legal or constructive obligation to transfer economic benefit to a third party, it is probable that a transfer of economic benefits will be required in settlement, and the amount of the obligation can be measured reliably.

Expenditure is classified by activity. The costs of each activity are made up of the total of direct costs and shared costs, including support costs involved in undertaking each activity. Direct costs attributable to a single activity are allocated directly to that activity. Shared costs which contribute to more than one activity and support costs which are not attributable to a single activity are apportioned between those activities on a basis consistent with the use of resources. Central staff costs are allocated on the basis of time spent, and depreciation charges are allocated on the portion of the asset's use.

#### 1.5 Tangible fixed assets

Tangible fixed assets are initially measured at cost and subsequently measured at cost or valuation, net of depreciation and any impairment losses.

Depreciation is recognised so as to write off the cost or valuation of assets less their residual values over their useful lives.

The gain or loss arising on the disposal of an asset is determined as the difference between the sale proceeds and the carrying value of the asset, and is recognised in the statement of financial activities.

### 1 Accounting policies (Continued)

#### 1.6 Impairment of fixed assets

At each reporting end date, the charity reviews the carrying amounts of its tangible assets to determine whether there is any indication that those assets have suffered an impairment loss.
