Achievements and performance

Summary of the main achievements of the charity during the financial period

Chairman's Report. [REDACTED] thanked [REDACTED] for his outstanding work in running the club 10 mile time trials and the club membership, [REDACTED] for looking after our finances and [REDACTED] for our excellent website. He thanked Sinclair Bay SubSea for again generously supporting our Festival of Cycling Race Weekend in June. He noted that, like ourselves Wick Wheelers membership numbers were down and a significant factor was that Cycling UK no longer gave insurance cover for club events to affiliated clubs. [REDACTED] reported that our use of the Rugby Club to host the Interclub proved to be very successful. **Secretary's Report.** [REDACTED] reported that we had affiliated to Scottish Cycling and Cycling Time Trials, but not to Cycling UK, as they no longer covered club events. He and [REDACTED] had examined the clubroom chimney, which needed minor repairs. He said that [REDACTED] was keen to establish Club Gravel Rides, which was much appreciated. He had looked into future possible options regarding the clubrooms 'as we are a registered charity, and concluded that there were not likely to be insuperable problems if, in the future, we needed to dispose of them.

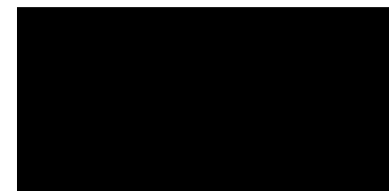
