Purposes: 'the provision of recreational facilities, or the organisation of recreational activities, with the object of improving the conditions of life for the persons for whom the facilities or activities are primarily intended', 'the relief of those in need by reason of age, ill-health, disability, financial hardship or other disadvantage'

What the charity does: The Peedie Retreat Charity aims to build and operate a fully bespoke accommodation to be used for short stays for residents of Orkney facing the challenges of Cancer, Multiple Sclerosis or Motor Neurone Disease. This haven is for the person affected, their family and carers to have time to rest recuperate and we hope, time to find a little happiness and leave feeling rejuvenated and a little stronger. The Retreat's central location will be ideal for friends support networks and professional and third sector support service to enhance the quality of peoples lives. We operate a fundraising team and actively carry out community fundraising which is further enhanced by the recent opening of a charity shop which is securing revenue funding to secure future operations of the Retreat for years to come. We are striving toward the construction phase with contracted builders and professional services and are working with design team and surveyors finalising plans and building warrants.

Beneficiaries: 'People with disabilities or health problems'

Objectives: 4 The organisation's purposes are: 4.1 To provide for the people of Orkney who suffer from Multiple Sclerosis, Cancer or Motor Neurone Disease (MND) and their family, support and carers, fully accessible, comfortable accommodation, free of charge, for short stay respite breaks. 4.2 To provide a tranquil environment where people whose mental health, physical and financial wellbeing has been detrimentally impacted because of their life limiting health condition can feel rejuvenated and valued, increase their self-esteem and self-worth, share time with their families and friends and create positive and

happy memories. 4.3 To provide support for Children in Orkney who are living with Cancer, MS or MND or are Young Carers, or have siblings, family or friends living with these conditions. Providing awareness, understanding, developmental activities and education around these conditions.



The charity is administered in accordance with the terms of the Scottish Charitable Incorporated Organisation constitution.

Trustee recruitment and appointment

The board may at any time appoint any member to be a charity trustee and members may appoint other members to be a charity trustee at each AGM.
At each AGM the charity trustees must retire from office, however they are then eligible for re-election.
As per the constitution, the minimum number of charity trustees is 3 and the maximum is 9.

Objectives and activities

Charitable purposes

To provide the people of Orkney who suffer from Multiple Sclerosis, Cancer or Motor Neurone Disease, their family, carers, and support networks, access to a bespoke designed fully accessible, comfortable accommodation, with innovative mobility aids to ensure the accommodation is suitable for all stages of the conditions. To be free of charge, for short stay respite breaks. To support those in need by reason of age, ill-health, disability, financial hardship, or other disadvantage as a direct result of the challenges of their medical condition.

Summary of the main activities in relation to these objects

Building Warrant approved.
Grant received from Orkney islands Council for grant towards pre-tender professional contracts and tender documents issued to 7 builders. Two tenders received by tender date.
Evaluation of tenders and progress made on cost reduction.
Fundraising activities ongoing.
Thanks to kind donation the chaity opened a New2You charity shop in Sept 24.
Ongoing engagement with the community to highlight the Charity's aims and objectives.

Summary of the main achievements of the charity during the financial period

Designs progressed and Building Warrant received
Grant received from OIC for the pre-tendering process and evaluation

Tenders issued to 7 local Building contractors with 2 returned tenders. Both tenders judged to be too expensive for the size of the building and methods investigated to try to reduce the costs. However this proved not to be possible with the original design so decision made to investigate a Kit frame design with initial contacts made with providers.

Progressing with Title deed transfer to Charity, which can only be completed when new design is approved by OIC.

Engaged with Statutory, Public and 3rd Sector Services for implementation of service delivery.

Social media used extensively with regular posts to update success stories and extend community support

Webpage in use.

Engagement with local media to highlight successful fundraising activities. And wider community support.

Fundraising and PR at local events, including County Show, Vintage Rally, Craft fairs, KGS and Stromness Academy YPI projects, presentation to various Clubs and organisations, have all been extremely successful.

Received the use of a shop on Kirkwall's main shopping street to run as we see fit with minimal rent to owner, this extremely kind offer has enabled us to run a New2You shop since Sept 24, this has been a very successful funding stream.

Received many donations and events held for charity donation including, Friends of Neuro, Music aboard Boy Ryan vessel, Quarryfield Garden event, Jive Dance Night, NFUMIS – Donation, Peedie Cubby, Orkney Builders, Quoy of Houton Garden event, St Magnus Cathedral, Skail House Xmas fair, Sammy Wilson sponsored walk, Virgin Bank, Anonymous donations.

1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities and Trustee Investment (Scotland) Act 2005. The financial statements have been prepared under the historical cost convention.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Tangible fixed assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

Taxation

The charity is exempt from tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.
