To educate and promote health awareness and community resuscitation for the benefit of the whole community and improve survival from life threatening emergencies.
To provide accessible accredited First Aid training and First Aid Event cover.
To enable volunteer First Responders to attend Pre-emergency Ambulance Care Interventions according to their training.
To help and support the elderly and vulnerable in our community.

Summary of the main activities in relation to these objects

We work with our community councils and local groups to install and maintain Public Access Defibrillators. We deliver Lifesaver CPR & Defibrillator awareness training regularly in every community setting including schools. We train & equip volunteer responders in pre-hospital emergency care to provide event cover, work with Fife Council falls team and the drug death reduction naloxone programme.
We work in partnership with the Scottish Ambulance Service to co-ordinate & train volunteer Community First Responders who respond to 999 emergencies.
We deliver Christmas Meals to the elderly and vulnerable.

APPENDIX 1

Achievements and performance

Summary of the main achievements of the charity during the financial period

We have continued as a key partner in the Scottish Government Initiative "Save a Life For Scotland", developing strategies to improve survival from Out-of-Hospital Cardiac Arrest and resources to support those involved. The GoodSAM initiative shows huge potential for the future and is a programme we are delighted to be involved with.

Our Community First Aid awareness training has been delivered to community groups including primary and secondary schools and we have actively targeted groups and individuals with a disability. We have trained 1,873 people this year

We have delivered accessible accredited First Aid training to groups and individuals including job seekers, those with mental health and addiction problems.

Responders attended 238 emergency 999 calls with our Scottish Ambulance Service CFR partnership work in the year to 31st March.

We have also continued our work to consolidate and develop the Fife Council Mobile Emergency Care Service Partnership within the East Neuk. The MECS team attended 176 calls during the year

Post COVID we have engaged with and supported the community with Medical Event Cover at significantly more events and activities.

We delivered a meal and gifts made by local primary school children on Christmas Day to 100 elderly or vulnerable members of our community most of whom lived alone.

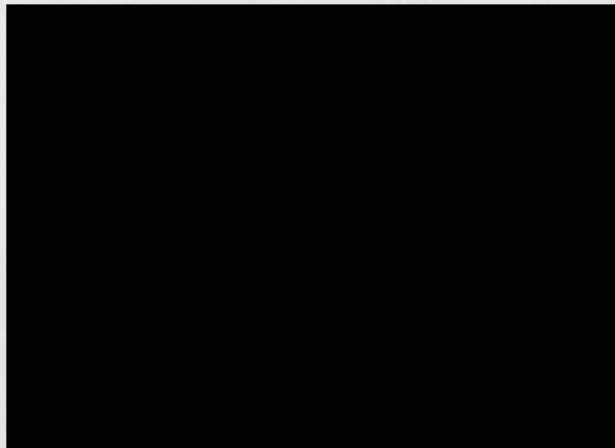

I report on the accounts of the charity for the year ended 31st March 2025 which are set out on the following page

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006. The charity trustees consider that the audit requirement of Regulation 10(1)(d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1)(c) of the Act and to state whether particular matters have come to my attention.

Basis of independent examiner's statement

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

Independent examiner's statement

In the course of my examination, no matter has come to my attention

1. which gives me reasonable cause to believe that in any material respect the requirements:
