Trustee recruitment and appointment

Trustee recruitment and appointment is addressed at clauses 64-74 of the 'CONSTITUTION of Corstorphine Athletic Club', in summary:

- At each AGM, the members may elect any member (unless they are debarred from membership under clause 67) to be a charity trustee.
- The board may at any time appoint any member (unless they are debarred from membership under clause 67) to be a charity trustee.
- At each AGM, all of the charity trustees elected/appointed under clauses 69 and 70 (and, in the case of the first AGM, those deemed to have been appointed under clause 68) shall retire from office – but shall then be eligible for re-election under clause 69.

Objectives and activities

Charitable purposes

The club's purpose is to operate as a non-profit distributing charity whose principal objective is the promotion of interest and community participation in the sport of athletics in the area of Corstorphine and the surrounding area.

Summary of the main activities in relation to these objectives

The main activities undertaken in the sport of athletics are track & field, road running, cross country, trail running, hill running and frame running.

Further the club's vision statement is:

'We will strive to ensure our athletes, coaches, officials, volunteers and our community maximise their individual potential in athletics and their daily life. We will ALL work towards OUR vision by creating a fun, safe, friendly, positive, inclusive and supportive environment.'

Achievements and performance

Summary of the main achievements of the charity during the financial period

The following achievement have been noted for the year ended 28th February 2025:

- In addition to existing training groups, a new JogScotland 10-week training block for beginner runners was announced in May 2024.
- Frame runner ██████████ won a national award recognising his contribution to sport and desire to help others, ██████████ was named the Rotary GB & Ireland Young Citizen Sporting Hero 2024.
- Corstorphine AAC hosted the inaugural Frame Running Festival at Saughton in June 2024. The event was a great success with 20 frame runners from six different clubs across Scotland attending. A total of 15 heats were run with a host of PBs and great performances across the board.
- Corstorphine AAC's Club Together Officer ██████████ was named as one of the recipients of the 2024 Eric Liddell Recognition Awards. The awards recognise the passion, compassion and integrity of some of the outstanding individuals who contribute to athletics in Scotland.
- Around 100 athletes took part in the club's annual Track and Field Championships at Saughton. Competitors from under-9 to Masters age groups as well as frame runners took part in a range of track and field events. Meanwhile, members and spectators once again donated a raft of grocery items that were dropped off at local foodbank Community One Stop Shop (COSS) Broomhouse. Hailing the gesture, COSS said: "It's donations like these which mean we can keep offering our services to those who need them."
- ██████████ won the Endeavour Award for athletes who have consistently driven to be the best they can be throughout the year at the Lothian Disability Sport Awards. CAAC also won the Lothian Disability Sport Club of the Year award.
- Corstorphine AAC was honoured for the second consecutive year at the Scottish Athletics 4J Awards in October 2024 after being named Para Development Club of the Year. The accolade, presented in memory of the late ██████████ recognises the ongoing growth and development of the frame running group.
- Corstorphine AAC's social events, the ceilidh at Bainfield Bowling Club in January 2025 and quiz night at Corstorphine Cougars RFC in December 2024, raised £881 to be used for the Transport to Training initiative which helps youngsters attend training sessions.
- ██████████ won the British 100k title at the Sri Chinmoy event at North Inch Park in Perth in April 2024. He also helped secure team gold for Scotland in the Anglo Celtic Plate home countries event. He was then selected to represent Great Britain at the IAU World 100km Championships in India in December 2024 where he helped the Great Britain men's team win bronze.
- ██████████ smashed the club's Vet 10-mile record in March 2024 by winning his age category at the Tom Scott Memorial Road Races at Strathclyde Park.
- ██████████ set a new club record of 2hrs, 19 mins and 56 secs with a brilliant run in the London Marathon. Tom finished 15th in the mass race, securing silver in the Scottish Championships in the process behind Olympian Callum Hawkins.
- ██████████ was crowned M40 Scottish 5k champion with a club record run at the Sri Chinmoy race at Silverknowes in May 2024.
- ██████████ broke the 31-year-old record to win the Highland Cross duathlon, he completed the 50-mile event, comprising a 20-mile run and 30-mile cycle, in 3:13:13. He was then chosen to represent Scotland at the 49th Snowdon International Race in July 2024.
- ██████████ won her first individual national title as she claimed the Scottish Under-20 women's 3,000m crown in May 2024, smashing a club record in the process finishing in 9 mins 56.09 secs.
- ██████████ participated in the Scottish Disability Sport National Senior Track and Field Championships at Grangemouth in September 2024. He set three championship records in the 100m, 200m and 400m and was selected to compete in the 2024 UK School Games in the 100m.

Financial review

Brief statement of the charity's policy on reserves

The charity held £81,741 in reserves at 28th Feb 2025, £12,649 is held in the Frame Running and Transport to Training restricted funds, and £69,092 is held in unrestricted funds.

The trustee's policy is to invest the charity's income back into club coaching, facilities and equipment at a sustainable level consistent with its receipts.

Further the trustee's policy is to maintain a significant level of unrestricted funds in reserves to:

- provide a level of funding in the event that the charity is required to invest in existing or new facilities in the longer term in order to maintain its objectives
- meet future fluctuations in receipts and payments as was required during the Covid-19 pandemic
