TRUSTEES REPORT FOR YEAR ENDED 28TH FEBRUARY 2025

The Trustees present their report and financial statements for the year ended 28th February 2025.

The financial statements have been prepared in accordance with the accounting policies set out in Note 1 to the financial statements and comply with the Charities and Trustee Investment (Scotland) Act 2003 and the Charities Accounts (Scotland) Regulations 2006.

Objectives and Activities

The purpose of the organization is to provide recreational facilities and advance the social needs, health and wellbeing of men of all ages and backgrounds living in Ayr with others r and district by:-

- Creating, developing and maintaining a facility, namely a Men's Shed.
- Offering opportunities for men in Ayr and Prestwick area to meet and undertake creative, physical, purposeful and recreational activities of their choice.
- Reducing isolation of men in the area thus contributing to their physical and mental wellbeing
- Developing the capacity of men in the Ayr and Prestwick area to share their skills and knowledge with others in the community.

The Trustees have paid due regard to guidance issued by the Charity Commission in deciding what activities the charity should undertake.

Significant Activities

The organization is working to achieve the objectives and goals as stated above and has succeeded in securing funding and premises.

Financial Review

The results for the year are set out in the financial statements on pages 6 – 10.

In the opinion of the Trustees the state of the charity's affairs is satisfactory.

As at 28/02/25 the General Fund stood at £13,811 (2024 £16,414).

Future Plans

The charity continues to seek opportunities to raise funds for the Men's Shed and has raised £49,029 Since the Balance Sheet date.

Recruitment and appointment of new trustees

Trustees are generally recruited from those volunteers showing a great interest and involvement in the project and often bring a great deal of knowledge, experience and support to the charity.

Organisational Structure

The day-to-day management of the charity is delegated to the Chairman and Vice-Chairman along with the help of other Trustees.

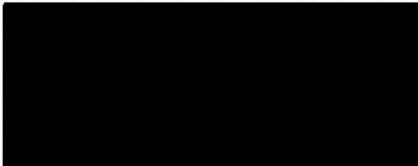

STATEMENT OF TRUSTEES RESPONSIBILITIES

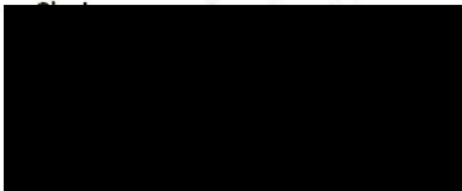

INDEPENDENT EXAMINER'S REPORT

TO THE TRUSTEES OF AYR AND PRESTWICK MEN'S SHED

I report on the financial statements of the charity for the year ended 28th February 2025 which are set out on pages 6 to 10.

Respective responsibilities of Trustees and Examiner

The charity's trustees are responsible for the preparation of the financial statements in accordance with the terms of the Charities and Trustees Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006.

The charity trustees consider that the audit requirement of Regulation 10(1)(d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1)(c) of the Act and to state whether particular matters have come to my attention.

Basis of Independent Examiners Report



• **Charity information**

Ayr and Prestwick Men's Shed is a charity situated in Scotland with registered address [REDACTED]. The charity's No. is SC051591.

• **Accounting convention**

The financial statements have been prepared in accordance with the charity's constitution. They have been prepared to comply with the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006.

The financial statements are prepared in sterling and they have been rounded to the nearest £.

The financial statements have been prepared under the historical cost convention.

• **Going Concern**

The Trustees have a reasonable expectation that the charity has adequate resources to continue in operational existence for the foreseeable future. Thus the Trustees continue to adopt the going concern basis of accounting.

• **Charitable Funds**

Unrestricted Funds are available for use at the discretion of the trustees in furtherance of their charitable objectives.

Restricted funds are subject to specific conditions by donors as to how they may be used.

• **Income**

Income is recognized when the charity is legally entitled to it after any performance conditions have been met.

Cash donations are recognised on receipt. Legacies are recognized on receipt.

• **Expenditure**

Liabilities are recognized as expenditure as soon as there is a legal obligation committing the charity to that expenditure.

• **Tangible Fixed Assets**

There are no Tangible Fixed Assets.

• **Investments**

There are no Investments

• **Accounting estimates**
