What the charity does: Our purposes, as recorded in our Constitution, are to promote animal welfare, specifically to abandoned and stray cats through the provision of shelter, veterinary attention, rehabilitation, rehoming and advancing the education of the public in the essential needs of cats. We raise funds through tombolas & raffles, as well as through seeking donations. We pay vet bills to help stray cats, and also in some circumstances to directly fund vet treatment of domestic cats whose owners were in financial difficulty. This includes the neutering of cats. We also house stray cats ourselves while they are being treated and to rehabilitate them for rehoming.

TRUSTEES' REPORT

FOR THE YEAR ENDED 5 APRIL 2025

The trustees present their annual report and financial statements for the year ended 5 April 2025.

The financial statements have been prepared in accordance with the accounting policies set out in note 1 to the financial statements and comply with the charity's constitution, the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 (as amended) and "Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102)" (effective 1 January 2019).

Objectives and activities

Our purposes, as recorded in our Constitution, are to promote animal welfare, specifically to abandoned and stray cats through the provision of shelter, veterinary attention, rehabilitation, rehoming and advancing the education of the public in the essential needs of cats.

Achievements and performance

This year was busier than last year, leading to higher spend on vet bills.

A big investment this year was the construction of a new hut for housing end-of-life cats in our care, which completed in May 2025.

We applied for a number of grants for funds, especially to support vet bills and to continue work on the feral colony we have been working with.

Financial review

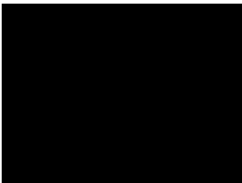
As a result of the surplus of £19,502 (2024: £14,112) for the period, we held unrestricted funds of £46,171 (2024: £26,669) at the end of the period.

Structure, governance and management

Stray Cat Rescue Fife is a Scottish Charitable Incorporated Organisation ("SCIO") and the purpose and administration arrangements are set out in our Constitution. The charity was registered by the Office of the Scottish Charity Regulator ("OSCR") on 22 February 2022 and commenced trading in April 2022.

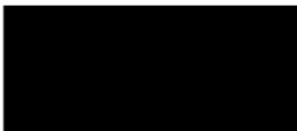

Statement of trustees' responsibilities

The trustees are responsible for preparing the Trustees' Report and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).

The law applicable to charities in Scotland requires the trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the charity and of the incoming resources and application of resources of the charity for that year.

In preparing these financial statements, the trustees are required to:

- select suitable accounting policies and then apply them consistently;
- observe the methods and principles in the Charities SORP;
- make judgements and estimates that are reasonable and prudent;
- state whether applicable accounting standards have been followed, subject to any material departures disclosed and explained in the financial statements; and
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue in operation.

The trustees are responsible for keeping adequate accounting records that disclose with reasonable accuracy at any time the financial position of the charity and enable them to ensure that the financial statements comply with the Companies Act 2006, the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006. They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

INDEPENDENT EXAMINER'S REPORT

TO THE TRUSTEES OF STRAY CAT RESCUE FIFE SCIO

I report on the financial statements of the charity for the year ended 5 April 2025, which are set out on pages 4 to 8.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the financial statements in accordance with the terms of the Charities and Trustee Investments (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006. 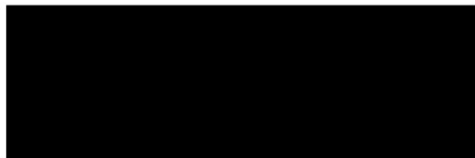
Basis of independent examiner's statement


