Chair report

From a sporting perspective the club has had a successful year, putting on several events, attending others and also having notable individual successes.

The Stornoway Half Marathon and 10k was successfully staged again along with the rebranded Mini Marathon which I believe exceeded expectations. The Half Marathon had two Local winners [REDACTED] and [REDACTED]. The Wacky Races series, Traigh Hard events and a cross-country race season were also well attended and executed. The organisation involved in these is significant so huge thanks to all those involved, as well as the many who support in other ways, such as marshals and timekeepers, a special mention to the Donner family who for the past four years, this dedicated family has been the driving force behind every SRAC XC race. The club also sent large squads to ND track & Field and NDXC championships, and 2024 saw the senior club trip heading to Odense, with some of our European members joining the trip.

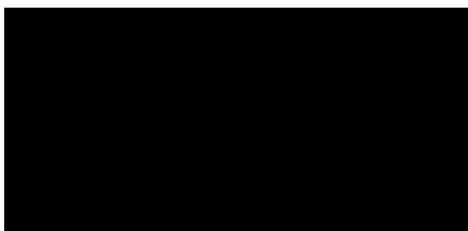
For the seniors [REDACTED] had particular success with both breaking club records, [REDACTED] breaking [REDACTED] incredible record that had stood since 1989 with an incredible 2:25 marathon win at Blackpool and [REDACTED] with a phenomenal 1:23 in Inverness, breaking a record that had stood since 2011.

Junior training was paused over the summer whilst policies and procedures were put in place, ensuring we move forward as a club on a sound footing, these were added to the website along with other documents such as codes of conduct, standing orders and the constitution. Junior athletes saw notable success, [REDACTED] won Scottish Schools Cross Country title and her most recent vest her 8th cap, which is 4 more than any other club member ever. [REDACTED] for winning Scottish schools High Jump.

From an administration perspective the year has seen us lose our Chair in [REDACTED] [REDACTED] as he moved away, we thank him for all his hard work during his time as Chair and club captain. Unfortunately, we've since been unable to fill the role of Senior men's captain. I'd like to give a special mention to [REDACTED] for taking on the role of Social media officer and the hard work she's put into the role since taking it on.

We should recognise the hard work and dedication from all those involved in the club. The coaches, the large number of parent helpers and club members who regularly volunteer their time, the board members, to support sporting activity and development. I would especially like to thank [REDACTED] for their contribution and hard work.

On behalf of the club, I would like to record thanks to everyone who has contributed in all of their many ways over the last year, it is greatly appreciated.
