Summary of the main activities in relation to these objects

The charity hosts pop up film events that focus on protagonists and filmmakers from underserved communities. They are held in accessible venues with a range of ticket prices to reduce barriers to attendance as much as possible. Film submissions are welcomed from everyone, and are advertised on social media.

The other main activity of the charity is collating and sharing educational content on social media that highlights barriers to access and how the outdoors can become a more supportive and welcoming place for all.

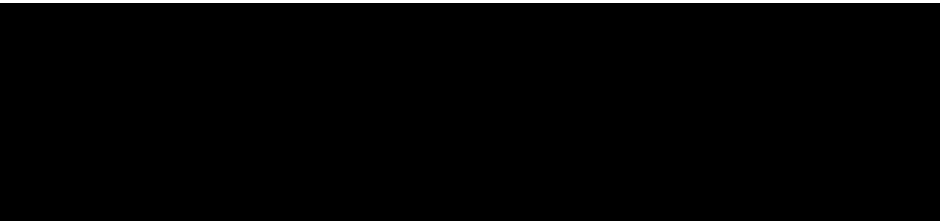
The charity has decided to dissolve due to life and work commitments of the members. Any activities carried out would be on an event by event basis.
