The trustees have pleasure in presenting their report together with the financial statements for the year ended 31st January 2025.

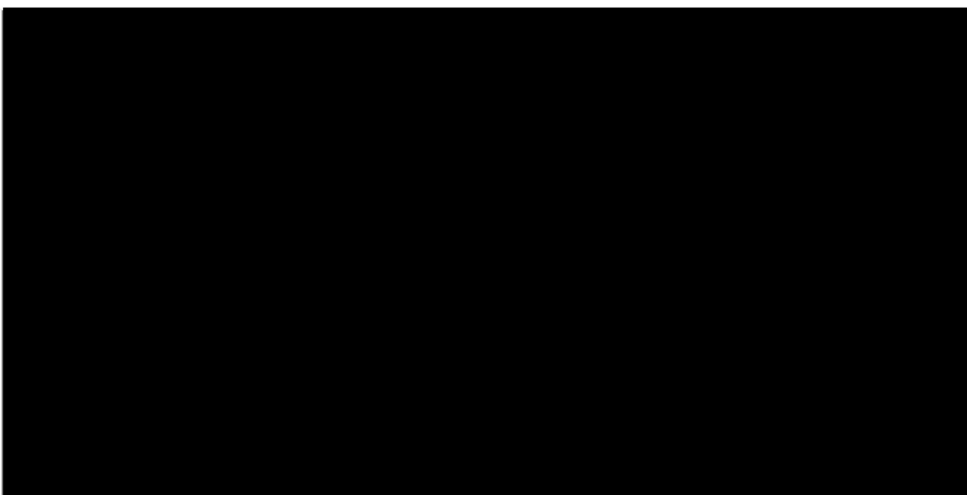

Structure, Governance and Management Constitution

The structure of the organisation consists of:

- the MEMBERS - who have the right to attend members' meetings (including any annual members' meeting) and have important powers under the constitution; in particular, the members appoint people to serve on the board and take decisions on changes to the constitution itself;
- the BOARD of Trustees- who hold regular meetings, and generally control the activities of the organisation; for example, the board is responsible for monitoring and controlling the financial position of the organisation.

Membership is open to any individual aged 18 or over who resides in Strachur and district. Employees of the organisation are not eligible for membership. A copy of the constitution is available on request to the Secretary.

Charitable Purposes

The organisation's purposes are:

- to combat social isolation and associated mental health issues by providing a safe, fully-accessible social and recreational space;
- to offer opportunities for local people to meet and undertake creative, physical and purposeful activities of their choice;
- to develop capacity to share skills and knowledge within the community.

Chairperson's Report

Once again the Shed was involved in designing and making the scenery for the local drama group's productions of Shrek and Beauty and the Beast. [REDACTED]

Christmas lights at Heron Park were organised by [REDACTED] and involved other organisations within the village – many of whom donated lights.

A very generous donation was made of a 6' x 4' trailer. It is in excellent condition. Going forward, ideas for this are needed.

Preparations for the Wellbeing garden are ongoing.

I would like to thank the committee for all their help over the last 2.5 years. I would also like to thank [REDACTED] our Secretary, for her hard work during this period.

Treasurer's Report

During the year we received donations from several individuals totalling £3,220 plus £50 from the Community Council and £30 from Strachur Memorial Hall Committee. Members took part in four fundraising events, generating further income of £1,693. We also received grants of: £500_Robertson Trust; £12,000_Awards for All (to be used for the establishment of a "Well-being Garden" in Heron Park, where we have decided to establish a well-being garden in the year 25/26); £1,000_Albert Hunt Trust.

Throughout the year general expenditure was kept to a minimum of Hall/Pavilion rental plus costs incurred for fundraising. The major expenditure items were due to planning application and building warrant costs. It is expected that a further £950 for construction and tender documentation will be necessary before building work commences. £1,500 in cash is being held for the purchase of a Portacabin in relation to the grant from Awards for All.

Note: Basis of accounting _ These accounts have been prepared on the Receipts and Payments basis in accordance with the Charities & Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended).





Independent Examiner's Report

Report to the Trustees of Strachur Community Men's Shed _ SC051984

I report on the accounts of the charity for the year 1st February 2024 to 31st January 2025, which are set out on pages 1 to 4.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006.

The charity trustees consider that the audit requirement of Regulation 10(1) (d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

Basis of independent examiner's statement

The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

In the course of my examination, no matter has come to my attention.

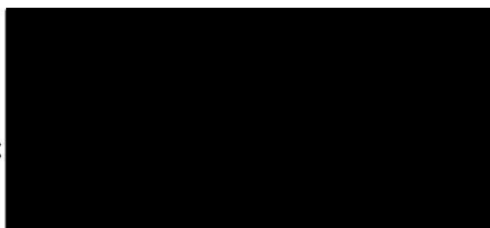
