What the charity does: Muslim Welfare House Scotland is established to promote social welfare, equality, and community cohesion, with a focus on tackling Islamophobia and discrimination. The charity currently undertakes no financial activities and has no income or expenditure. Our work is delivered through non-financial activities such as community engagement, awareness-raising, education, and signposting individuals to appropriate support services. We aim to challenge misconceptions, reduce prejudice, and support those affected by Islamophobia through advice, guidance, and advocacy. All activities are carried out by volunteers who give their time and skills to serve the community. We work collaboratively with local mosques, community groups, and partners to promote understanding, inclusion, and mutual respect. Through volunteer-led initiatives and community engagement, we seek to create a safer and more cohesive society.

Type of governing document

The charity is controlled by its governing document, Constitution of Muslim Welfare House Scotland and registered with OSCR dated September 2022 (SC052040).

Trustee recruitment and appointment



