## Report of the Trustees for the year end 31 December 2024

The trustees present their annual report and financial statements of the charity for the period ended 31 December 2024. The financial statements have been prepared in accordance with the accounting policies set out in the notes to the accounts and comply with the charity's constitution, the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 (as amended) and Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland.

### **Aims and Affiliation**

Cornerstone Free Church of Scotland is a congregation of the Free Church of Scotland working towards the common aims set out below. It is a Presbyterian church adhering in its worship and doctrine to the position of the Church of Scotland at the Reformation. The Free Church of Scotland has an explanatory document which explains the origins of the Church and which gives the historical background to the Church coming into being in 1843 and lists documents in which is embodied the constitution of the Church. The document is available on request from the Free Church of Scotland, 15 North Bank St., The Mound, Edinburgh, EH1 2LS.

The Free Church of Scotland currently has over 100 congregations in Scotland, as well as one in London and several in North America, and sister Churches founded by mission work in India, Peru and South Africa. The Church also has a seminary in Edinburgh for the training of ministers and other Christian workers and sustains an extensive missionary programme relative to the size of the church. The principal activity of the Church is the conduct of public worship and associated matters in the context of local congregations.

Dating from 1843 but with its roots in the Reformation, the Free Church of Scotland owes its distinctive title to its historical struggle to remain 'free' from state interference in its internal affairs. It has close and active relations with many other Reformed churches of Jesus Christ throughout the world and stands firmly in the tradition which accepts the Bible in its entirety as the Word of God and, therefore, derives its forms of teaching, worship, ministry and government from it. The main emphasis of our worship is the preaching of the gospel - the good news of a free and sovereign salvation through Jesus Christ alone.

The congregation is authorised by the Church to have a Minister and an assistant Minister paid from central funds of the Church.

The church building and the minister's manse are held by St Columba's Free Church, Edinburgh, under the Church's model trust deed but are in the process of being transferred into the name of Cornerstone Free Church.

## **Achievements & performance**

During the year, the congregation met regularly for public worship and carried out various activities in pursuit of the above stated aims.

The congregation continued its commitment to support the National Free Church of Scotland both spiritually and financially.

Significant highlights, events and developments of note in the year include the following: -

In relation to **congregational activities**:

- Continued to serve local families through Morningside Minis, a parent and toddler group
- Provided opportunities for people to gather to discuss faith and belief
- Partnered with the Wayfarer Trust to support Christians in the arts and creative endeavours
- Sunday Services continued at George Watson's College throughout 2024 to accommodate growing numbers.

In relation to **congregational funding**:

- A growth in donations from church members via weekly offerings and Gift Aid donations.
- Increased participation by church members in the Gift Aid scheme.

## **Financial Review**

Income and expenditure both increased this year. Overall there was a surplus of £42,392 (2023: £70,409) for the period. Unrestricted funds at the year end were £78,629 (2023: £17,340).

Restricted funds, held for the purposes detailed in note 14, were £34,172 (2023: £53,069) at the end of the year.

## **Reserves policy and going concern**

The trustees are working to develop a satisfactory level of reserves to be retained by the charity. There is no formal reserves policy approved by Trustees but unrestricted net current assets at year-end were £72,008 (2023: £9,805), which would equate to more than three months of unrestricted expenditure.

The Trustees have reviewed the circumstances of the charity and consider that adequate resources continue to be available to fund the charity's activities for the foreseeable future. The Trustees are of the view that the charity is a going concern.

## **Risk Management**

The Trustees are responsible for assessing the risks to which the congregation is exposed on an ongoing basis and for periodically updating and reviewing it. The Trustees assess the risk in relation to health and safety in line with the requirements of the FCoS central church. The Trustees seek to identify and address the material risks facing the congregation and agree measures aimed at mitigating these risks.

## **Plans for future periods**

We continue to pursue opportunities to expand our ministry, specifically by establishing a church plant in the Gilmerton area. This initiative will be driven by existing members residing in Gilmerton and will aim to build a strong community presence. Furthermore, we are dedicated to fostering the growth of our Spanish-speaking congregation. To facilitate these endeavours and further our mission of sharing Jesus, we intend to utilize the old schoolhouse. This space will serve as a hub for both Christian and local community groups, providing support and resources to the wider community.

We are looking to assist in establishing two church plants in the Edinburgh area, using the experience we have gained over recent years. We aim to continue the congregation's current activities and develop further outreach with students and young workers and to play a leading role in the promotion of Biblical Counselling within the church and the wider denomination. We will continue developing our partnership with Wayfarer Trust to sustain artists and promote the creative arts.

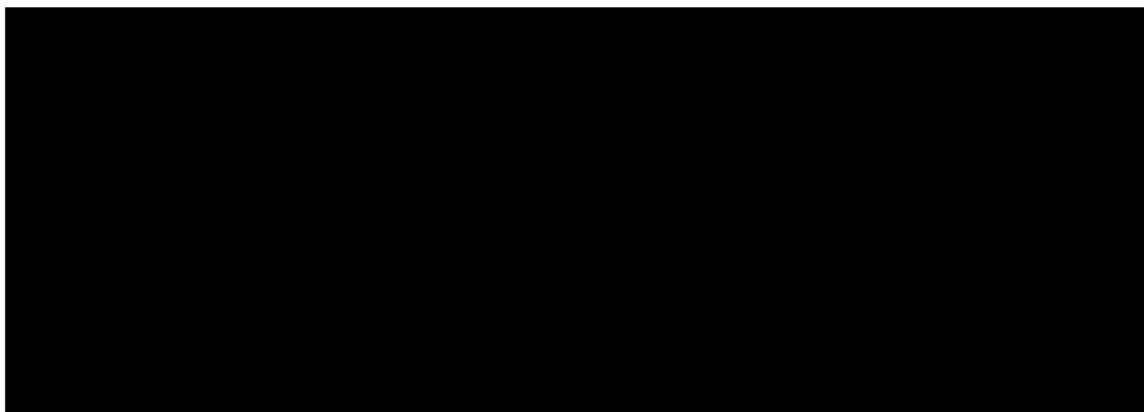
## Structure, Governance and management

Cornerstone Free Church of Scotland is established by Constitution. It is a registered Scottish Charity (No. **SC052057**), registered on 11 October 2022.

## Trustees and Office Bearers

The congregation is governed and administered by elected office bearers (all volunteers) and its minister, assistant minister and church planter. The Kirk Session, being the minister, assistant minister, church planter and elected elders, has responsibility for spiritual oversight, while the Deacons' Court, composed of Kirk Session members plus elected deacons, oversees financial and property matters. Under Charity Law, the Deacons' Court are deemed to be the trustees of the congregation as those with responsibility for day-to-day management and control. This is distinct from the role of property (congregational) trustees who are responsible only for holding property in trust.

The members of the Deacons' Court (the Trustees) who served during the period and since the period of year end, were as follows:



## Appointment of Charity Trustees

The Kirk Session exercises its discretion in determining the most appropriate method of electing new Trustees (Elders and Deacons). Any election process must involve the communicant membership of the congregation. There is no fixed term for Trusteeship. Prior to their appointment, new Trustees would have served the Church for some time in various roles and would be familiar with the Church's values, its aims and objectives as well as its day-to-day operations. As part of their induction programme, new Trustees are required to understand their statutory responsibilities as well as the responsibilities of their office within the congregation as elder or deacon.

## Statement of Trustees' responsibilities

### Trustees' responsibilities in relation to the financial statements

The charity trustees are responsible for preparing a trustees' annual report and financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).


The law applicable to charities in Scotland requires the charity trustees to prepare financial statements for each year which give a true and fair view of the state of affairs of the charity and of the incoming resources and application of resources, of the charity for that period. In preparing the financial statements, the trustees are required to:

- select suitable accounting policies and then apply them consistently;
- observe the methods and principles in the applicable Charities SORP;
- make judgements and estimates that are reasonable and prudent;
- state whether applicable accounting standards have been followed, subject to any material departures disclosed and explained in the financial statements;
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue in business.

The trustees are responsible for keeping proper accounting records that disclose with reasonable accuracy at any time the financial position of the charity and to enable them to ensure that the financial statements comply with the Charities and Trustee Investment (Scotland) Act 2005, the Charity Accounts (Scotland) Regulations 2006 (as amended), and the provisions of the Trust deed. They are also responsible for safeguarding the assets of the charity and taking reasonable steps for the prevention and detection of fraud and other irregularities.

The trustees are responsible for the maintenance and integrity of the charity and financial information included on the charity's website. Legislation in the United Kingdom governing the preparation and dissemination of financial statements may differ from legislation in other jurisdictions.

## **Independent Examiner's Report to the Trustees of Cornerstone Free Church of Scotland**

I report on the accounts of the charity for the year ended 31 December 2024 which are set out on pages 10 to 20.

### **Respective responsibilities of trustees and examiner**

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended). The charity trustees consider that the audit requirement of Regulation 10(1) (a) to (c) of the 2006 Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

### **Basis of independent examiner's statement**

My examination is carried out in accordance with Regulation 11 of the 2006 Accounts Regulations. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

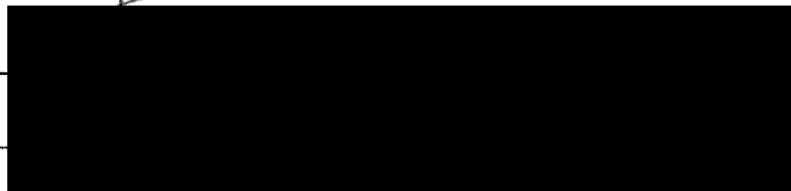

### Notes forming part of the financial statements

#### 1. Accounting Policies

The principal accounting policies, which have been applied consistently in the current and preceding year in dealing with items which are considered material to the accounts, are set out below.

##### **Basis of preparation**

The accounts (financial statements) have been prepared under the historical cost convention with items recognised at cost or transaction value unless otherwise stated in the relevant note(s) to these accounts. The financial statements have been prepared in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS 102), the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended).

The charity constitutes a public benefit entity as defined by FRS 102.

The Trustees consider that there are no material uncertainties about the charity's ability to continue as a going concern.

##### **Fund accounting**

Funds are classified as either restricted funds or unrestricted funds, defined as follows:

*Restricted funds* are funds subject to specific requirements as to their use which may be declared by the donor or with their authority or created through legal processes, but still within the wider objects of the charity.

*Unrestricted funds* are expendable at the discretion of the Trustees in furtherance of the objects of the charity. If parts of the unrestricted funds are earmarked at the discretion of the Trustees for a particular purpose, they are *designated* as a separate fund. This designation has an administrative purpose only and does not legally restrict the Trustees' discretion to apply the fund.

##### **Income**

Income is recognised when the charity has entitlement to the funds, any performance conditions attached to the item(s) of income have been met, it is probable that the income will be received and the amount can be measured reliably.

##### **Donated Services and facilities**

Donated professional services and donated facilities are recognised as income when the charity has control over the item, any conditions associated with the donated item have been met, the receipt of economic benefit from the use by the charity of the item is probable and that economic benefit can be measured reliably. In accordance with Charities SORP (FRS102) the general volunteer time of church members is not recognised.

On receipt, donated professional services and donated facilities are recognised on the basis of the value of the gift to the charity which is the amount the charity would have been willing to pay to obtain services or facilities of equivalent economic benefit on the open market; a corresponding amount is then recognised as expenditure in the period of receipt.

##### **Interest Receivable**

Interest on funds held on deposit is included when receivable and the amount can be measured reliably by the charity; this is normally upon notification of the interest paid or payable by the bank.

##### **Expenditure**

Expenditure is recognised when a liability arises.

##### **Fixed Assets**

The charity has the right to occupy and use for its charitable objects certain tangible fixed assets, including the Church vested in the Free Church of Scotland central church Board of Trustees. No consideration is payable for the use of these assets. Expenditure incurred on the repair and maintenance of these assets is charged as expenditure in the Statement of Financial Activities in the period in which the liability arises.

**1. Accounting Policies (cont.)**

Tangible fixed assets are held at cost and depreciated on a straight line basis over the estimated useful life of the asset as follows:

Fixtures, fittings & equipment      25%

Costs of assets over £50 are capitalised. A full year of depreciation is charged on the year of purchase for fixtures, fittings and equipment.

**Investments**

Cornerstone Free Church of Scotland does not hold any investments at this time.

**Pension**

Subject to the rules of auto-enrolment, staff are enrolled into the pension scheme used by the Free Church of Scotland. It is a defined contribution scheme in which the congregation makes a 10% contribution. Employees can opt to make additional contributions but there is no obligation to do so.

**Taxation**

Cornerstone Free church of Scotland is recognised as a charity for the purposes of applicable taxation legislation and is therefore not subject to taxation on its charitable activities. The charity is not registered for VAT and

**2. Related Party Transactions, Trustees' Expenses and Remuneration**

In 2024 payments totalling £86,789 (2023: £75,882) were made to the central denomination, covering remittances to central funds including the Missions Board, presbytery dues, conveyancing, payments for services and goods (payroll handling fees, gift aid administration, the Free Church's Record magazine and photocopying). As ministers of the denomination, three of the Trustees were paid stipends by the central denomination in 2023 and 2024.
