- (v) To help alleviate the causes and effects of poverty,
- (vi) To share the Gospel of Jesus Christ in words, deeds, and actions, and
- (vii) To engage with the local community."

Achievements and performance

Summary of the main achievements of the charity during the financial period

Ministry Engagements and meetings:

- Leading the prayer sessions for Christian business conference in Switzerland, through my contacts in the Glasgow Pastor's group,
- Helping host online prayer meetings for our family of churches throughout the year (monthly),
- Provided cover preaching at a United Free Church near Glasgow,
- Facilitating prayer meetings at Young Hearts Church and churches in Zimbabwe, sharing best practices, and building international connections,
- Providing the training and strategy in the lead up to the Thrive 25 conference,
- Hosting and attending Edinburgh and Glasgow pastors' prayer meetings (weekly),
- Church conferences online, and in person monthly over the year.

Local Church Involvement:

- Continuing to preach and lead prayer ministry at my local church, training others, and encouraging participation.
- Continuing to produce a video blog series on biblical books, which has gained significant engagement and serves as a tool for evangelism and prayer. Currently this resource is accessed and listened to by hundreds of people each month. The resource is not only used to bless the church but also as a training tool for members of the local church who are being equipped and trained through COP.
- Hosting monthly church meetings and ad hoc prayer meetings for special occasions/events.

Relationship Building and Influence:

- Much of this year has been spent building trust and relationships with church leaders (mainly in Glasgow and Edinburgh), aiming to inspire a culture of prayer and support churches in developing their prayer life. This has included attending or leading the Edinburgh or Glasgow weekly and monthly in person and Zoom prayer meetings, along with many meetings on the sidelines of these times of prayer.
- Meeting around fifty church and ministry leaders over the year to discuss prayer culture and ministry.
- Conducted two prayer surveys for pastors covering questions regarding gathered prayer and its impact in the local church.

Vision, Strategy, and Challenges for the Concert of Prayer:

- A revised vision for the Concert of Prayer—to make Scotland 'revival ready' by cultivating a culture of prayer in churches—and discussed the challenges of engaging busy church leaders and congregations, seeking input from trustees on strategy and messaging has been provided.
- Vision Statement and Strategic Focus: The vision is to equip churches across Scotland to enjoy and prioritise prayer, aiming for transformation at both leadership and congregational levels. The strategy involves training, equipping, and modelling prayer practices to foster lasting change.

Ongoing challenges in shifting church culture, noting that many leaders and members are preoccupied with activities and programmes, making it difficult to prioritise prayer. He highlighted the need for a cascade effect from leaders to congregations and the importance of addressing both corporate and individual devotional life.

Resource Sharing and External Models are being explored with meetings ongoing and planned – including the use of external resources and models, to inform and potentially enhance the ministry's approach.
