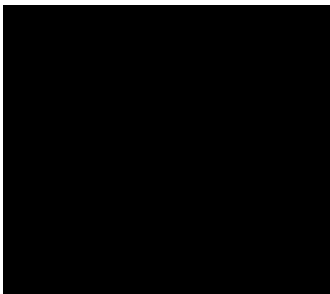

Structure, Governance and Management

Constitution

The Charity is a Scottish Charitable Incorporated Organisation (SCIO). It was registered in its current legal form on 5 January 2023. It has a single tier structure and as such the trustees are the sole members of the charity.

Appointment of trustees

Trustees are elected at the annual general meeting which is held in January. There must be a minimum of three (3) and a maximum of five (5) trustees. Charity Trusteeship is open to any person aged 16 or over; and/or any individual who has been nominated for membership by an unincorporated organisation; and/or any corporate body, who subscribes to the purposes of the organisation and wishes to see them fulfilled.

Charitable purposes

To undertake scholarly research into the history and genealogy of the communities that make up the Western Sephardic diaspora in the Atlantic world; and to identify and make available original source documents, materials and research, and to publish these in databases or physical publications, in order to inform and educate a worldwide public. The area within which the organisation shall operate shall be worldwide.

Achievements and Performance

Following on from the publication of transcriptions of three years' accounts in 2023, in FY2024 we published transcriptions of a further eight manuscript books and are transcribing three further books.

We have also carried out a translation and e-book experiment with the first volume of the Livro dos Pleitos. Chat-GPT 4 was successfully used to generate an AI-aided translation of the book, and dummy .pdf and flipbook editions were produced. The results are promising enough to justify scaling up to other transcribed manuscripts, and we are pursuing funding from the National Lottery Heritage Fund to put in place the technical infrastructure.

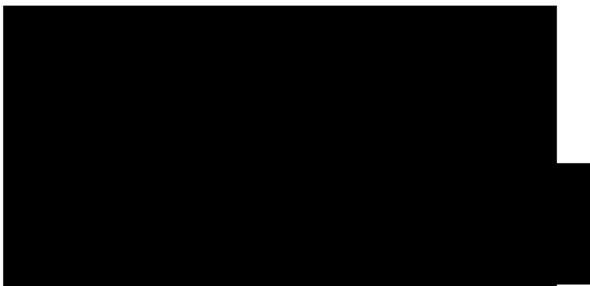

Financial review

Our main source of funding is in the form of grants from funding bodies and donations from members of the public and from trustees.

We received £125.88 in donations from trustees in the year to 31 December 2024. We did not initiate any fundraising from members of the public in FY 2024.

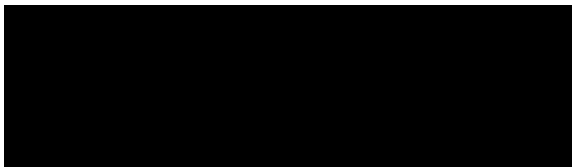
In July 2024 we changed our webhosting provider from 1and1 IONOS Ltd, to which we were paying £12.60 per month in hosting costs, to the Manchester-based hosting provider 34SP.com. As a registered charity, we were able to negotiate free hosting from 34SP.com.

In September 2024 we applied to His Majesty's Revenue and Customs (HMRC) for recognition as a charity for tax purposes, specifically for registration for the purpose of Gift Aid. The application was accepted, and we were issued the Charity Ref No. ST05901. As a requirement of the HMRC application, we were asked to open a new bank account with a bank that is registered with the Financial Services Compensation Scheme (FSCS). HMRC would not accept Wise Ltd, as although Wise is authorised as an Electronic Money Institution (EMI) by the Financial Conduct Authority (FCA), it is not a bank and is not FSCS-registered. We therefore opened an account with Zempler Bank, which fulfills this requirement. Our bank account details as of 31 December 2024 are:

Notes to the accounts - for the year ended 31 December 2024

1 Basis of accounting

These accounts have been prepared on the Receipts and Payments basis in accordance with the Charities & Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended)

2 Nature and purpose of funds

Independent examiner's report to the Trustees of A Nação Hebraica (SCIO) for the year ended 31 December 2024

I report on the financial review and accounts of the charity for the year ended 31 December 2024 which are set out on pages 8-10.

1 Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended). The charity trustees consider that the audit requirement of Regulation 10(1) (d) of the 2006 Accounts Regulations does not apply. It is my responsibility to examine the financial review and accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

2 Basis of independent examiner's statement

My examination is carried out in accordance with Regulation 11 of the 2006 Accounts Regulations. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of transactions mentioned in the review and I am satisfied that the review is accurate and that A Nação Hebraica (SCIO) derives beneficial ownership of the contracts mentioned. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

3 Independent examiner's statement

In the course of my examination, no matter has come to my attention which gives me reasonable cause to believe that in any material respect the requirements to keep accounting records in accordance with Section 44(1) (a) of the 2005 Act and Regulation 4 of the 2006 Accounts Regulations to prepare accounts which accord with the accounting records and comply with Regulation 9 of the 2006 Accounts Regulations have not been met.
