## **Trustees' Report for the year ended 30 April 2025**

The Trustees present their annual report and accounts for Renew for the year to 30 April 2025.

### **STRUCTURE GOVERNANCE AND MANAGEMENT**

#### **Structure and Governing Document**

Renew was registered as a charity on 12 April 2023 in the form of a Scottish Charitable Incorporated Organisation with the charity number SC052472. Renew is governed by a constitution which clearly sets out its purposes and how the Charity is to be administered by the Trustees.

#### **Trustees**

The Trustees who served from incorporation and throughout the period are noted on page 4. The Trustees are responsible for the governance, supervision and defining the strategy and objectives of Renew. The Trustees also have principal responsibility for finance, fundraising, policies and procedures, risk management and contractual obligations. The Trustees engage regularly to fulfil their duties.

The Constitution permits the appointment of up to 7 Trustees and requires a minimum of 3 Trustees. At the year-end and throughout the period, 5 Trustees held office.

Trustees come from a variety of backgrounds and experience with the expectation that they will evidence their commitment to Renew through setting aside sufficient time to participate in regular Trustees meetings in the use of the skills for the benefit of the Charity. The appointment of new Trustees is the responsibility of the existing Trustees.

#### **Risk Management**

The Trustees have examined the major strategic and operational risks which Renew faces and confirm that adequate systems and controls are in place to mitigate such risks. Matters relating to risk management are addressed at meetings of the Trustees and local Leadership.

#### **Aims**

The charitable purposes of Renew as set out in the Constitution and are

- the advancement of Christian faith
- the advancement of community development/ community engagement

## **ACHIEVEMENTS AND PERFORMANCE FOR THE PERIOD ENDED 30 April 2025**

### **Activities in this reporting period**

In our second year of operating, we built upon the strong foundations of our first year by securing funding for the ongoing work, investing in key leaders and gathering churches from across the city for prayer and training. A mapping exercise in June 2024 gave us a clearer picture of the current missional opportunities and from this we prioritised some specific neighbourhoods in Edinburgh to work towards some new missional communities.

We continue to gather leaders to encourage and train in the areas of mission and church planting. This year it's been encouraging to see new churches and individuals joining our work. We have seen a number of people participate in the Forge pioneer course and new additions to our church planting huddle. The leaders that we train and coach are taking steps forward in new pioneering and church planting work and through this we're seeing new communities being engaged.

The second half of the year has been more transitional with key personnel moving within the city or preparing to move on. This has limited some of the plans for the year but there is still a strong commitment to develop the work of Renew.

### **Financial Review**

In the period reported in these accounts, unrestricted income amounted to £6,016 Unrestricted charitable expenditure of £1,635 was incurred resulting in an overall unrestricted surplus for the period of £4,381.

Restricted income was received during the period for staff costs amounting to £3,841. Expenditure incurred was £9,506, leaving £1,335 restricted funds held at the end of the period. This fund is to be used to pay for Aaron Elder's time and will be paid by agreement to his employer Oxfangs Community Church.

### **Reserves Policy**

The Trustees have yet to set a Reserves Policy, but without fixed costs there is not an urgency to do this.

### **Plans for future period**

Given the changes in the Renew leadership, the year ahead will be a year of managing this transition. We want to encourage our staff member to finish well in his role and then we expect a period of vacancy in this position. We will create some space by simplifying our offering and taking time to seek God for what will come next. We will continue to focus on our 4 priorities: prayer, partnership, pioneering & planting. We want to make sure that supportive relationships between leaders are prioritised in the year ahead.

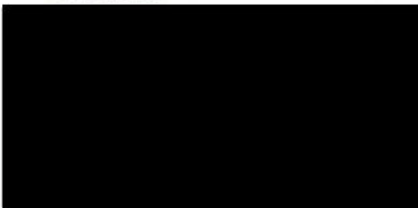

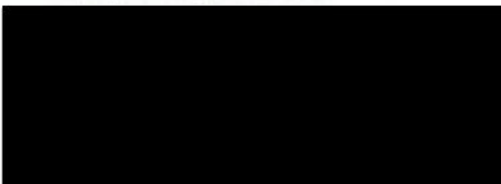

**Independent Examiner's Report to the Trustees of Renew**

**Notes to the Accounts for the Period Ended 30 April 2025****1 Accounting Policies****Basis of Accounting**

- The accounts have been prepared on receipts and payments basis in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended).

**Nature and purpose of funds**

- Unrestricted Funds are those that may be used at the discretion of the trustees in furtherance of the objects of the charity. The trustees maintain a single unrestricted fund for the day to day running of the organisation.
- Restricted Funds may only be used for specific purposes. Restrictions arise when specified by the donor or when funds are raised for specific purposes. During the year, the SCIO held or received grants restricted for the purpose of funding salary costs.

**Donations, legacies and similar incoming resources**

- Donations, legacies and similar incoming resources are included in the year in which they are received. No legacies were received during the period covered in these accounts. The charity benefitted from the accumulated funds generated by the organisation prior to becoming a charity.

**2 Transactions with Trustees**

There were no transactions with Trustees and no Trustees receive remuneration for their role as Trustees. The charity has an agreement with Oxfangs Community Church to pay for some of [REDACTED] time. The first payment was made during this year and another after the current year end. [REDACTED] is a Trustee of both charities but was not involved in the preparation of the terms of the agreement.
