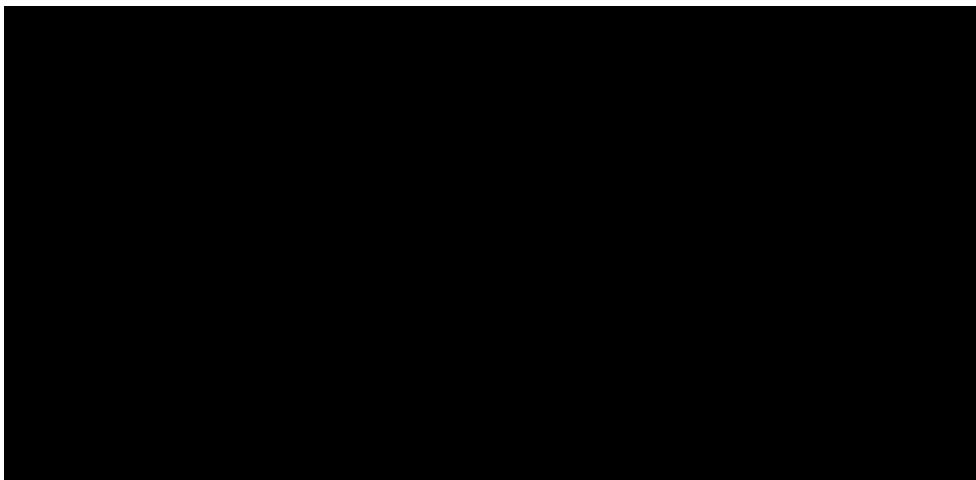

## Financial (Treasurer) Report

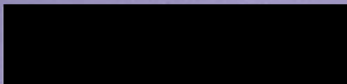
Ardrossan Winton Rovers Youth Academy SCIO operated during the year 2024/25 operating various teams within the organisation who managed their own individual accounts.
