We have arranged social events for the group and have 5 vice captains that volunteer to help run these events and games etc

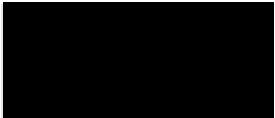
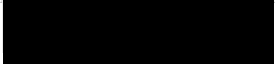
