Charitable purposes

Summary of the main activities in relation to these objects

During the reporting period, the charity continued to pursue its objectives of advancing the Christian faith, promoting community development, and providing relief to the less privileged. The main activities included:

- **Religious Services and Prayer Meetings:** Weekly prayer meetings were held both online and monthly in-person prayer meetings, creating opportunities for members and non-members to engage in worship, fellowship, and spiritual growth.
- We provided one-to-one counseling services to support members of the congregation with their spiritual and emotional needs.
- We ran outreach activities which included the collection and distribution of food parcels, and religious materials to individuals and families experiencing hardship in Glasgow and surrounding communities.

Achievements and performance

Summary of the main achievements of the charity during the financial period

The charity achieved significant progress in advancing its purposes and serving the community over the financial year:

- **Increased Participation:** Attendance at weekly prayer meetings and physical service activities grew by approximately 25%, reflecting stronger engagement from both members and newcomers. Online meetings enabled a wider reach beyond the immediate local area.
- **Expanded Counselling Support:** More than 30 one-to-one counselling sessions were provided, offering much-needed guidance and emotional support to individuals facing personal challenges.
- **Community Food Support:** The charity's outreach was strengthened through support from Greggs, who provided snacks, meals, and baked items beginning from March 2025. These contributions, distributed alongside our food parcels, directly benefited families and individuals experiencing food insecurity. This partnership has had a meaningful impact by ensuring more consistent support for those in need and fostering stronger connections with the local community.
