Achievements and performance

Summary of the main achievements of the charity during the financial period

Our charitable status was awarded on 18th March 2024.
Our constitution was ratified on 23rd May 2024.
We remain in a period of transition, from a sports and social club to a SCIO.

The existing club has a 25 year lease which is due to expire in 2027

Our focus for the remaining reporting period has been aimed solely on renewal of our ground lease with South Lanarkshire Council.

The new lease will be in the name of the charity, allowing us to transfer assets and fully transition to SCIO.

As of 31st Dec 2024 we have not yet agreed details of a new lease with SLC.

Our plan for the coming year is to continue negotiations with SLC and move towards securing a long term lease, transfer assets and continue fund raising for an ambitious redevelopment of our clubhouse building, in line with our club development plan.

As yet, our charity has no assets.

Other optional information

Our negotiation with South Lanarkshire Council is complicated by our unusual site. Lanark Thistle Bowling Club sits on the site of the former Lanark Castle and as such is a scheduled monument with Historic Environment Scotland. Our situation is further complicated by the fact that our site is also designated "common good" land. To date, we have agreed with SLC the principle of a lease renewal, over a longer period of time than the existing lease. We are still negotiating the more complex issues of cost and transfer of maintenance responsibilities.
