What the charity does: The charity is set up to provide recreational facilities and advance the social needs, health and well being of men of all ages and backgrounds living in the Sanquhar and District area by: A) Creating ,developing and maintaining a facility, namely the Men's Shed, B) Offering the opportunities for to meet and undertake creative ,physical, purposeful ,and recreation facilities of their choice, C) Reducing isolation ,thus contributing to their health and wellbeing, D)|Developing the capacity of men to share their skills and knowledge with others in the community. How the above is done. The shed is a rented church hall with the shed having exclusion rights to the building.. The building provides a socialising area with a library, television ,pool table and facilities for carrying out light projects, such as painting and model making. The workshop area is divided into work stations where specific types of projects are carried out, such as painting, crook making, wood turning etc.

Objectives: The purpose of the organisation is to provide recreational facilities and advance the social needs, health and well being of men of all ages and backgrounds living in Sanquhar and District By: a) Creating, developing and maintaining a facility, namely a Men's Shed. b) Offering opportunities for men in the Sanquhar area to meet and undertake creative, physical, purposeful and recreational activities of their choice. c) Reducing isolation of men in the area thus contributing to their physical and mental wellbeing. d) Developing the capacity of men in the Sanquhar area to share their skills and knowledge with others in the community.

Structure Governance & Management

Constitution

The Charity is unincorporated. It is governed by its constitution which was adopted in 2024.

Appointment of Trustees

The management committee, which normally meets on a quarterly basis, are the charity's trustees. Membership of the management committee is open to anyone over the age of 18. Trustees are elected at the Annual General Meeting which is normally held in October each year. Under the constitution, trustees serve for a period of 3 years and can be nominated for re-election.

Management

The trustees are responsible for the management of the trust. The trustees decide on a voting majority basis as to which organisations should benefit from the trust funds.

Trustee remuneration and expenses

The trustees did not receive any remuneration or expenses during the year

Financial review

As a result of the surplus of £5,248 for the year, the charity held restricted funds of £4,537 and unrestricted funds of £6,497.16. There are no designated funds.

Reserves policy

The trustees' policy is to maintain reserves at around £2,000. Reserves at the year end were £11,034.

Independent Examiner's Report to the Trustees of Sanquhar & District Men's Shed

I report on the accounts of the charity for the year ended 31st March 2025 which are set out on pages 4 to 6.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006. The charity trustees consider that the audit requirement of Regulation 10(1) (d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

Basis of independent examiner's statement

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

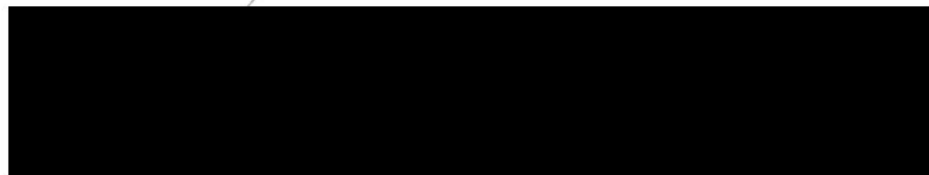
Independent examiner's statement


