What the charity does: Our charity is established to promote environmental protection and alleviate poverty in disadvantaged areas of Tanzania. We achieve this by promoting sustainable land use through reforestation, coffee and avocado farming, and the establishment of tree nurseries. We've received a six-acre land donation in Loriko Boloti, Hai District, Kilimanjaro, where we will plant indigenous trees to combat deforestation and soil erosion on Mt. Kilimanjaro. These efforts also support local livelihoods by creating jobs and providing food security through fruit tree gardening and eco-agriculture. Our work blends environmental restoration with community empowerment.

During the year ended 31 December 2024, the charity did not receive any income or incur any expenditure. However, key foundational milestones were achieved:

- A six-acre land donation was received from the local community in Loriko Boloti, Hai District, Kilimanjaro, to establish tree nurseries, coffee and avocado farming, and fruit tree gardening.
- A website and social media platforms were launched.
- Partnerships with local stakeholders were established to begin reforestation and community upliftment activities in line with our constitution.

The charity remains committed to its mission and is now prepared to begin fundraising and project implementation in the coming year.

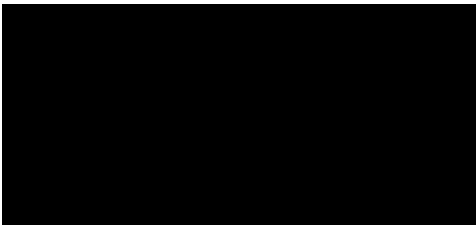
