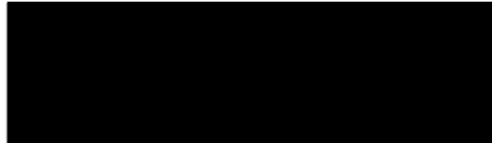

## STRUCTURE GOVERNANCE AND MANAGEMENT

---

### Governing Document

Carnwath Community Development Trust (CCDT) is a Scottish Charitable Incorporated Organisation (SCIO) which was registered on 8<sup>th</sup> May 2024 and is governed by its constitution.

### Appointment of Trustees

The trustees are elected at the AGM or co-opted during the accounting year.

### Organisational Structure

The organisation is two tier organisation which is governed by its;

Trustees who hold regular meetings and generally control the activities of the organisation for example, the Trustees are responsible for monitoring and controlling the financial position of the organisation.

The members of the Trust who have the right to attend members' meetings (including any annual members' meeting) and have important powers under the constitution; in particular, the members appoint people to serve on the board and take decisions on changes to the constitution itself. The trust is volunteer led and had no employees during the reporting period.

## OBJECTS & ACTIVITIES

---

The charity's objects are: -

the advancement of citizenship or community development through the organising of community-based activities that foster pride in the community of Carnwath and surrounding areas.

the provision of recreational facilities, or the organisation of recreational activities, with the object of improving the conditions of life for the persons for whom the facilities or activities are primarily intended

## ACHIEVEMENTS & PERFORMANCE

---

Carnwath Community Development Trust has been established to assume some of the operational functions currently undertaken by Carnwath Community Council, allowing the Community Council to refocus on its core strategic activities. However, due to external complications, including the requirement from South Lanarkshire Council not to change bank accounts until the end of the building project, the transition process has been delayed, and all financial transactions and administrative activities have continued to be managed by the Community Council.

Despite these delays, CCDT has been actively delivering community-based initiatives. This includes engaging with residents, contributing to the update of the locality's Place Plan, organising community events such as Halloween and Christmas parties, supporting and collaborating with other community organisations, working in partnership with the local school, and liaising with the Community Council on the development and opening of the local circular economy community shop.

## FINANCIAL REVIEW

---

As per above the Development Trust has not been trading during this period and therefore has had no income or expenditure to report on.

## FUTURE PLANS

---

Carnwath Community Development Trust plans to develop its activities in the next financial year.

Key priorities include:

- **Ownership and management of the Village Enterprise Hub** – supporting local businesses and entrepreneurship.
- **Ownership and management of the Circular Economy Hub (Community Shop)** – a sustainable community resource.
- **Volunteer Training as a Route to Employment** – equipping local residents with skills, experience, and confidence to access employment opportunities.
- **Community engagement on the future of the area** – ensuring local voices shape priorities and decision-making.
- **Community activities**, including:
  - Over 50s Lunch Club
  - Dementia Coffee and Chat Group
  - Job Club

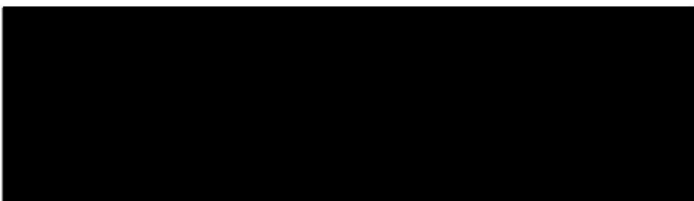
These initiatives aim to foster inclusion, wellbeing, and economic resilience across the community.

**Independent Examiner's Report to the Trustees of Carnwath Community Development Trust**

I report on the accounts of the charity for the year ended 31 March 2025, which are set out on pages 6 to 8.

**Respective responsibilities of Trustees and Examiner**

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 ("the 2005 Act") and the Charities Accounts (Scotland) Regulations 2006 (as amended) ("the 2006 Regulations"). It is my responsibility to examine the accounts under section (44)(1)(c) of the 2005 Act and to state whether particular matters have come to my attention.

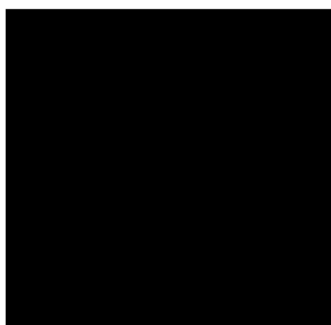
**Basis of Independent Examiner's Statement**

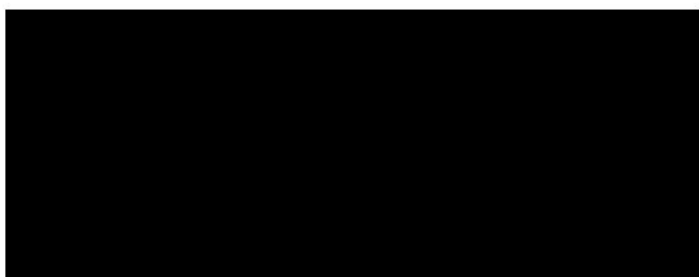
