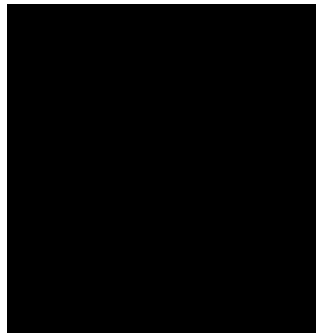

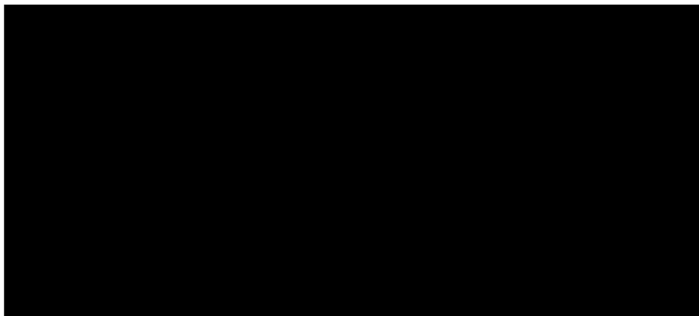
5. Financial Review
