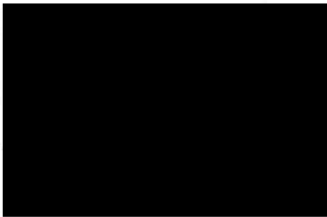

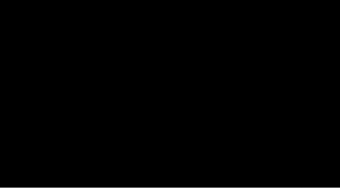

During the period, we organised Traveeh for the community from our centre.

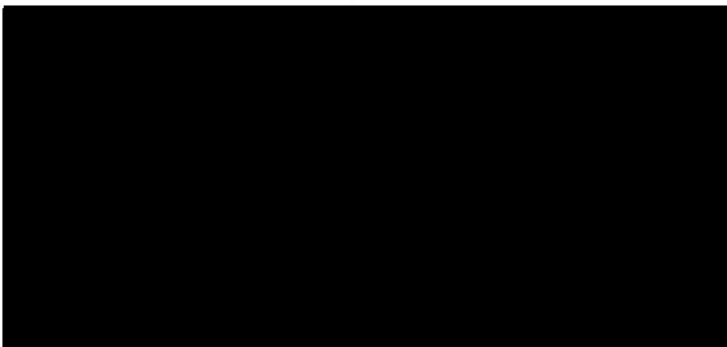
**Trustees' remuneration and expenses**

**INDEPENDENT EXAMINER'S REPORT TO THE COMMITTEE**

I report on the accounts of the charity for the period ended 06 April 2025 which are set out on pages 5 to 7.

**Respective responsibilities of trustees and examiner**

The charity's committee is responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006. The charity committee considers that the audit requirement under Regulation 10(1) (d) of the Accounts Regulations does not apply. **Basis of independent examiner's statement**

My examination is conducted in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the committee concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.
