What the charity does: This charity is set up to provide a safe space for young people (12yrs+) who identify as part of the LGBTQ+ community in Inverclyde. Our projects are art and culture based to aid our young people engage with the local LGBTQ+ community near and far. We also run focused sessions discussing mental health and wellbeing. We are running a queer book group which is based for 18yrs+.

1. Chairperson's Statement

I am delighted to present this year's Chairperson's Statement for TIME Inverclyde. This has been a year of remarkable growth, creativity, and community impact for our organisation and the young people we serve.

Our youth groups have continued to thrive, with attendance almost doubling over the year. This growth is a testament to the meaningful relationships built within the group and the trust young people place in us. We delivered 46 sessions, offering safe, educational, and empowering opportunities for LGBTQ+ young people across Inverclyde.

This year was defined by creativity and collaboration. Our young people engaged in an extensive range of workshops, from lino printing and collage to zine-making and creative writing, supported by partners such as the Glasgow Zine Library and Disobedient Magazine. The publication of a 48-page magazine and its launch at The Beacon was a highlight, showcasing the talent and resilience of our young people.

We also strengthened our presence across Inverclyde. From running a stall at the Comet Festival to forming new links with Inverclyde Libraries, TIME continues to be recognised as a valued part of the local community. Our trip to Glasgow Pride was another milestone, offering our young people a joyful, affirming experience at no cost to them.

Financially, we remain stable but cautious. With our current meeting space secured only until April 2026, our priority in the coming year will be to obtain sustainable funding and secure a long-term home for TIME. We are also excited to work toward delivering the first Pride parade in Inverclyde, a significant step in visibility and inclusion for our community.

I want to thank our trustees, volunteers, partners, and most importantly our young people. Their creativity, honesty, courage, and humour shape everything we do at TIME. As we look ahead, we remain committed to fostering a safe, empowering space where LGBTQ+ young people can learn, connect, and thrive.

2. Achievement & Performance

- We held 46 sessions with our young people this year. This equates to approximately 69 contact hours.
- We had guest led sessions from the Glasgow Zine Library and Sabrina Sigler from disobedient magazine.
- Our young people attended Glasgow Pride this year at no cost. The day included van hire and lunch.
- Our workshops culminated in a 48-page self-published magazine that was distributed for free at a launch event in arts venue: The Beacon.
- Our young people attended a lecture delivered by University of Glasgow lecturer Dr. Sam Rutherford about the lessons Section 28 can teach us about the modern-day trans panic.
- We were asked by Inverclyde Council to hold a stall at the annual Comet Festival celebration. The event was attended by over 500 people in Coronation Park in Port Glasgow.
- We secured free meeting space at the Port Glasgow Community Hub which will run until April 2026.

- This year our numbers have grown from 6-10 regular attendees to a regular group of 13. This is an almost 100% uplift.
- We were offered and attended a Christmas takeover market in Greenock. Our young people helped passers-by to make badges.
- We started an additional monthly group aimed at 18+. The queer book group meets in Port Glasgow library and has 6 members.
- The Queer Book group was facilitated by Inverclyde Libraries and was promoted using their official local authority social media.

3. Future Plans:

- Securing ongoing funding must be top priority. TIME's current meeting space expires in April 2026 with no future space secured.
- Re-establish The Queer Book Club.
- Additional growth in weekly attendance numbers, aim would be to split our current group into 2 smaller groups by age.
- Facilitate Inverclyde's first Pride parade in Battery Park in Greenock.
- Growth in online presence, measurable by traffic to our website.

Independent Examiner's Statement

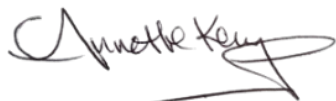
