(Ten) any other purpose for the benefit of the community that is charitable in law. and (Eleven) supporting such organisations or initiatives as my Trustees shall in their sole and absolute discretion think fit to support or establish and in such shares and proportions and subject to such terms and conditions as my Trustees shall appoint but always provided that such organisations or initiatives create or promote public benefit in accordance with sub-clauses (One) through to (Ten) above.
