Summary of the main activities in relation to these objects

Bargeddie Christian Fellowship has consistently maintained a local Christian church with regular Sunday services and ancillary services for the benefit of local people in Bargeddie.

Achievements and performance

Summary of the main achievements of the charity during the financial period

During the period ending 31st March 2026 the Fellowship had a weekly Public Sunday service, a Tuesday midweek service and a, monthly, Saturday Community lunch. Bargeddie Christian Fellowship also assisted and continues to assist with a monthly local primary School Assembly and fortnightly with a Service in a local care home. A fortnightly art-class is also held at the Centre organised by a fellowship member. Bargeddie Christian Fellowship has also conducted several Christian funeral services on behalf of the community. Bargeddie Christian Fellowship is growing slowly and has a vision to eventually employ a paid Christian minister to minister to the needs of the growing community it serves. There is a strong sense of fellowship amongst the members, who all volunteer their services, freely, in mutual support of the work. There is a positive outlook and vision for the future. The Fellowship is well known, and in good standing with the local community.

Financial review

Brief statement of the charity's policy on reserves

The Charity at present is careful to retain at least 50% of its finance as a reserve. As its own funds were only collected from January 2026 and these, although growing, are not substantial. NB Bargeddie Christian Fellowship, prior to its charity registration and the opening of its own bank account, worked as a sub set of Drumpellier Christian Fellowship who hold a Bargeddie Account with more substantial retained funds for Bargeddie. Drumpellier Christian Fellowship is in the process of transferring the building to Bargeddie Christian Fellowship. After this has cleared, funds in the Bargeddie Fund they hold, will be donated to Bargeddie Christian Fellowship's bank account. At that point a firm reserve amount will be allocated.
